**PETITION FOR CANCELLATION**

Petitioner, VISA INTERNATIONAL SERVICE ASSOCIATION (“Petitioner”), a Delaware membership corporation having its principal place of business at 900 Metro Center Boulevard, Foster City, California 94404, believes it is and will continue to be damaged by Registration No. 1,190,371 for VISALIX, and hereby petitions to cancel same.

As grounds for cancellation, Petitioner alleges:

1. MCE (“Registrant”), a company, upon information and belief, is the registrant of Registration No. 1,190,371 for the mark VISALIX for “facial lotions to be used after removal of makeup” in International Class 3.

2. Registrant is, upon information and belief, a company, having a place of business at 206 Boulevard de la Republique, 92210 Saint-Cloud, France.

3. Upon information and belief, Registrant is no longer using VISALIX as a trademark, Registrant has not used VISALIX as a trademark for well over three years, and therefore Registrant has abandoned the VISALIX mark pursuant to 15 U.S.C. § 1127.

WHEREFORE, Petitioner prays that this Petition for Cancellation be sustained and that Registration No. 1,190,371 for VISALIX be cancelled.


