Discovery period to close:	May 23, 2005
Thirty-day testimony period for party in position of plaintiff to close:	August 21, 2005
Thirty-day testimony period for party in position of defendant to close:	October 20, 2005
Fifteen-day rebuttal testimony period to close:	December 4, 2005

In each instance, a copy of the transcript of testimony together with copies of documentary exhibits, must be served on the adverse party within thirty days after completion of the taking of testimony. Trademark Rule 2.125.

Briefs shall be filed in accordance with Trademark Rule 2.128(a) and (b).

An oral hearing will be set only upon request filed as provided by Trademark Rule 2.129.
