As grounds for the petition, it is alleged that:

1. Petitioner is engaged in the business of banking and financial services.
2. Petitioner is owner of pending U.S. Trademark Application Serial No. 76/531,705 for the mark BIZACCESS for "electronic banking services provided via a global computer network, namely, savings account services, checking account services, direct deposit banking services, electronic funds transfer services, tax payment processing services, and electronic payment services, namely, processing and transmission of bill payment data," in International Class 36.
3. On information and belief, Registrant Citibank NA is a National Banking Association with an address at 399 Park Avenue New York NY 10043.
4. Registrant's Registration No. 1557202 has been cited against Petitioner's pending application Serial No. 76/531,705, because the Examining Attorney believes there may be a likelihood of confusion between Petitioners' marks and the Registrant's mark, which raises possible issues with respect to use and registration of Petitioner's marks. Therefore, Petitioner will be harmed by the continued registration of Registrant's mark.
5. On information and belief, Registrant's mark is no longer in use in commerce in the United States.
6. On information and belief, Registrant's mark has been abandoned.
7. For the reasons set forth above, Petitioner will be damaged by continued registration of Registration No. 1557202.
