12 **Procedural History**

13 On October 4, 2004, Agrigenic Food Corporation, d/b/a Biotec Foods (hereinafter
14 Petitioner) filed a Petition to Cancel Trademark Registration No. 1471924 for the mark "Biotech"
15 originally registered January 12th, 1988, by PDK LABS, INC. (hereinafter Respondent).

16 In accordance with the Trademark Rules of Practice, on October 6th, 2004, the United
17 States Patent and Trademark Office, Trademark Trial and Appeal Board notified Respondent of
18 the Petition to Cancel via mail, and set a answer due date forty days after the mailing date, for
19 November 15, 2004.

20 As of November 16, 2004, no opposition has been filed by Respondent nor has an
21 extension of time to file opposition been requested by Respondent nor granted by Petitioner,
22 and pursuant to Rule 2.113, 37 C.F.R. § 2.113, - If no answer is filed within the time set, the
23 opposition may be decided as in case of default.

24 On November 16th, 2004, this Motion for Default Judgment was prepared and served on
25 Respondent via mail according to the attached Proof of Service.

1 **Legal Standard**

2 Under Rule 2.113, 37 C.F.R. § 2.113, when a petition for cancellation is filed, the Board
3 "shall designate a time ... within which an answer must be filed." If the cancellation respondent
4 fails to file an answer within the time set by the Board, "the petition may be decided as in case
5 of default." (See Rule 2.114, 37 C.F.R. § 2.114.)

6 **Prayer**

7 Pursuant to Rule 2.113, 37 C.F.R. § 2.113, Petitioner hereby moves the Trademark Trial
8 and Appeal Board for a default judgment order canceling trademark registration No 1471924 for
9 the mark *Biotech*.
