PETITION TO CANCEL

Caesars Entertainment, Inc. ("CEI") and Caesars World, Inc. ("CWI"), (collectively "Petitioners"), believe they are being damaged by the registration of THE RESORT ROME, Registration No. 2,718,270 on the Supplemental Register for "business management and business development of casinos, resorts, hotels, restaurants, convention centers, entertainment and tourist destinations and amusement theme attractions, and products merchandising services for others," in International Class 35 owned by Cyrus Milanian, and hereby petition to cancel same pursuant to Section 13 of the Trademark Act of July 5, 1946, as amended, 15 U.S.C. 1063 and Rule 2.111 of the Trademark Rules of Practice.



As grounds therefor, it is alleged that:

The Petitioners And Their Roman Themed Marks

1. Caesars Entertainment, Inc., formerly Park Place Entertainment Corporation ("CEI"), is a corporation organized and existing under the laws of Delaware, with an office located at 3930 Howard Hughes Parkway, Las Vegas, Nevada 89109. CEI was known as Park Place Entertainment Corporation until January 5, 2004, when it filed the appropriate papers to change its corporate name to Caesars Entertainment, Inc.

2. Caesars World, Inc. ("CWI") is a wholly owned subsidiary of CEI and is a corporation organized and existing under the laws of the State of Florida, having an office and principal place of business at 3930 Howard Hughes Parkway, Las Vegas, Nevada 89109.

3. Cyrus Milanian ("Milanian" or "Registrant") is the owner of U.S. Registration No. 2,718,270 for THE RESORT ROME ("Registrant's Mark") for "business management and business development of casinos, resorts, hotels, restaurants, convention centers, entertainment and tourist destinations, and amusement theme attractions, and products merchandising services for others" in International Class 35.

4. CEI is one of the world's largest gaming company and owns, manages or has an interest in more than 20 hotel/casino resorts around the world operating under various trademarks including the famous BALLY'S, PARIS and FLAMINGO brands. Its wholly owned subsidiary, CWI, is the owner of the famous CAESARS brand, including the Caesars Palace Hotel in Las Vegas, Caesars Atlantic City in Atlantic City, New Jersey, Caesars Tahoe in Lake Tahoe, Nevada, and Caesars Indiana in Elizabeth, Indiana. In connection with its casino and gaming services, CEI and CWI also provide among other services, hotel, restaurant, bar, beauty

shop, barber shop, and spa and health club services, as well as entertainment services including nightclubs, sporting events and concerts. As is common in the gaming and hotel industry, CEI and CWI offer a wide variety of goods under the CAESARS mark as part of a comprehensive merchandising program. These goods include, but are not limited to, clothing, perfume, cologne, after-shave lotion, after-shave moisturizing crème, body moisturizing lotion, bath and shower gel, key chains, sunglasses, pins, playing cards, suit bags, tote bags, hand bags, travel toiletry cases, cups, mugs, coaster, bottle openers, shoe horns, glasses, ice buckets, towels, blankets, water, cigarette lighters, ash trays, wallets, dice, jewelry, watches,

CWI owns federal registration Nos. 968,212; 995,418; 1,201,555; 1,829,004; 2,630,525; 1,090,494; 1,191,413; 884,317; 954,637; 1,988,107; 1,531,548; 1,527,770; 907,694; 1,532,553; 1,001,363; 963,820; 954,684; 1,527,771; 907,696; 1,663,829; 1,186,958; 1,538,771; 963,656; 983,525; 951,262; 1,091,551; 907,693; 1,201,511; 1,158,035; 995,419; 1,263,220; 966,734; 1,004,058; 1,168,663; 1,063,525; 1,531,549 and 763,255 for CAESARS or CAESARS formative marks for goods and services in classes 3, 6, 9, 16, 25, 35, 39, 41, 42 and 43. Attached as Exhibit 1 are print-outs from the U.S. Patent and Trademark Office web site evidencing these registrations for the Caesars marks. Since its inception in 1966, the CAESARS brand has utilized a Roman theme that permeates each CAESAR branded property. For instance, at CAESARS PALACE a visitor can eat at NERO'S, disco at CLEOPATRA'S BARGE, shop at THE FORUM SHOPS and see Celine Dion at THE COLOSSEUM, Las Vegas' newest entertainment venue. CAESARS PALACE, CAESARS ATLANTIC CITY, CAESARS TAHOE, and CAESARS INDIANA are often referred to as THE EMPIRE. U.S. registrations encompassing this Roman theme include, but are not limited to registration Nos. 907,694 and 966,734 for I, CAESAR, Registration No. 1,143,658 for APPIAN WAY, registration No.

976,106 and 1,138,113 for CLEOPATRA'S BARGE, registration No. 965,251 for CIRCUS MAXIMUS, registration No. 1,146,922 for SPANISH STEPS, registration No. 1,676,542 for TOGA TEDDY, and registration No. 1,829,004 for THE FORUM SHOPS AT CAESARS. CWI also owns several state registrations reflecting the Roman theme, including, but not limited to, CAESARS, CAESARS PALACE, I, CAESAR, CLEOPATRA'S, and CLEOPATRA'S BARGE.

6. On or about July 1, 2004, CEI opened the ROMAN PLAZA. On August 24, 2004 CEI and CWI filed applications for ROMAN PLAZA.

7. In addition, CEI and CWI own several common law marks including, but not limited to ALL ROADS LEAD TO ROME, CAFÉ ROMA, ROMAN FEAST, GLADIATORS SPORTS BAR, EMPERORS ESSENTIALS, FORUM CASINO, FORUM TOWER, FORUM LOUNGE, CLEO'S COFFEE AND MORE, CLEO'S LOUNGE, NERO'S CONQUESTS, VILLA'S BUFFET, NERO'S EMPORIUM, CLUB NERO, NERO'S GRILL, EMPEROR'S LOUNGE, EMPEROR'S ESSENTIALS GIFT SHOP, ROMAN RITUALS, ROMAN RITUALS GIFT SHOP, CHARIOT RUN, AN EMPIRE OF ENDLESS POSSIBILITIES, THE EMPIRE ROCKS, AUGUSTUS CLUB, BUILT FOR AN EMPEROR, FIT FOR A KING, and EMPIRE OF ENTERTAINMENT.

8. The CAESARS INDIANA HOTEL ("CAESARS INDIANA") opened on November 16, 1998 and uses the GLORY OF ROME trademark in connection with gaming services in Indiana. Hotel accommodations and resort services are provided at CAESARS INDIANA adjacent to the floating casino branded the GLORY OF ROME, located on the banks of the Mississippi River. CEI and CWI also offer casino services at several themed casinos at

this location including the ROME CASINO and the BURNING OF ROME CASINO. The gift shop on THE GLORY OF ROME is called ROMAN RITUALS. THE ROME CASINO, BURNING OF ROME CASINO, have been in continuous use since at least as early as November 16, 1998. More than 14,000,000 people have enjoyed the gaming and entertainment services aboard THE GLORY OF ROME through May 31, 2004. In 2003 CEI and CWI spent more than \$2.8 million in advertising and promotion of CAESARS INDIANA, including the casino, gaming and entertainment services offered on THE GLORY OF ROME.

9. As a result of its use of THE GLORY OF ROME, ROME CASINO, BURNING OF ROME CASINO, and ROMAN RITUALS, CWI owns common law rights in these marks.

10. On July 2, 2004, CEI electronically filed application Serial No. 78/445,480 for GLORY OF ROME in class 41 for "entertainment services, namely, musical and comedy nightclub performances; live performances by singers, dancers, musicians, pantomimes, magicians, actors, actresses, comedians and acrobats; live variety shows, music concerts, boxing matches; sporting events; casino and gaming services; television productions," and in class 43 for resort, hotel, bar, restaurant, convention, nightclub, and lounge services." The first use date for both classes is at least as early as November 16, 1998. On September 17, 2004, CEI electronically filed Application Serial Nos. 78/485,663 for ROME CASINO for "casino and bar services" in classes 41 and 43, and 78/485,674 for BURNING OF ROME for "casino and bar services" in classes 41 and 43. The first use dates for both marks is at least as early as November 16, 1998.

11. In earlier years, Petitioners spent over 2.7 million in 2002, and over 3.5 million in 2001 in promotion and advertising CAESARS INDIANA, including THE GLORY OF ROME.

12. On average, CEI's website for the GLORY OF ROME has more than 30,000 hits a month.

13. CEI and CWI plan to continue to expand their use of the Roman themed marks, including the use of marks incorporating the words "Rome" and/or "Roman".

14. The CAESARS PALACE, CAESARS ATLANTIC CITY, CAESARS TAHOE, and CAESARS INDIANA hotel/casino resorts have continuously used a Roman theme to advertise and promote their hotel, resort, casino, entertainment and merchandising services.

15. Due to the nationwide promotion and Petitioner's longstanding use of CAESARS PALACE, CAESARS ATLANTIC CITY, the COLOSSEUM, and the other Roman themed marks, consumers immediately associate Roman themes used in connection with hotels and casinos with Petitioners.

The Registrant and His THE RESORT ROME Mark

16. On January 13, 2002, Registrant filed an intent-to-use application for ROME (Serial No. 78/102,388). Registrant later amended the application from the Principal to the Supplemental Register based on a May 2000 date of first use for "business management and business development of casinos, resorts, hotels, restaurants, convention centers, entertainment and tourist destinations, and amusement theme attractions and products merchandising services for others," in International Class 35. The specimen evidencing this use was a print out of the screen from the website <resortscenter.com>. This specimen stated "Cyrus Milanian offers for a fee his services, namely, business management of resort hotels, casinos and theme parks for others and merchandizing services for others internationally, and/or in the United States of

America, under one or more of the following trademark/service marks mentioned under its own title. Cyrus Milanian also offers for a fee to consult on business management of resort hotels, casinos, and theme parks and product merchandising services for others under one or more of the following trademarks mentioned under its own title . . .” Under this statement Milanian then listed the more than [200] marks either pending before the United States Patent and Trademark Office or registered in the United States.

17. On May 20, 2003, Serial No. 78/102,388 matured into Supplemental Registration No. 2,718,280 for “business management and business development of casinos, resorts, hotels, restaurants, convention centers, entertainment and tourist destinations, and amusement theme attractions and products merchandising services for others” in International Class 35.

18. Long prior to May 2000 and March 11, 2003, the first use and registration dates for Registrant’s THE RESORT ROME mark, Petitioner commenced use of its Roman theme marks for hotel and casino services in the United States, including, specifically, the marks GLORY OF ROME, ROME CASINO, and BURNING OF ROME CASINO.

19. Upon information and belief, the specimen submitted by the Registrant does not show use as defined in §45 of the Lanham Act. In *Caesars World, Inc. v. Milanian*, 247 F. Supp. 2d 1171, 1182 (D. Nev. 2003), the United States District Court, District of Nevada, reviewed claims by Milanian that he had prior rights in the mark COLOSSEUM based on an intent to use application for “business management of resorts, hotels, casinos and theme parks for others and products merchandising services” sufficient to prevent Plaintiffs from branding a new entertainment venue THE COLOSSEUM at CAESARS PALACE. A full trial on the merits was held in January 2003. During this trial it was established that Milanian had filed dozens of

trademark applications, almost all based on an intent to use for “business management of resorts hotels [sic], casinos and theme parks for others and products merchandising services,” or close variations thereof. *Id.* at 1182. The specimens submitted in support of virtually all these applications was a webpage from resortscenter.com. Initially this website stated “Cyrus Milanian offers for sale and or rent/lease in the United States of America and/or Global marketplace, and/or internet; *license rights and/or buyout rights* for goods and services advertising for sale or rent/lease in exchange for royalties/compensatory for the following trademarks, service marks,” however in response to office actions concerning other trademark applications, this language was modified. *Id.* at 1183 [*emphasis in original*].

20. The District Court of Nevada stated that Registrant did not have a bona fide intent-to-use the ROMAN EMPIRE and COLOSSEUM marks based on the following revised language on resortscenter.com:¹ “Cyrus Milanian offers for a fee his services, namely, business management and resort hotels, casinos, and theme parks for others and merchandising services for others internationally and/or in the United States of America, under one or more of the following trademarks/service marks mentioned under its own title.” [titles omitted]. The District Court went on to state that the filing of applications for these marks was part of Milanian’s “sham.”

21. On April 8, 2004, the District Court issued a bench warrant for Registrant for failure to pay sanctions. In an affidavit to the Court opposing Petitioners’ motion for a bench warrant, Registrant claimed his income amounted to “less than \$15,000” in 2003 and “less than

\$20,000” in 2002. He made no mention of the services offered under the THE RESORT ROME mark or under any of the marks listed in the specimen submitted to the Trademark Office. A copy of the Declaration is annexed hereto as Exhibit 2.

22. Upon information and belief, Registrant’s domain name, resortscenter.com, has been suspended and is currently inactive.

23. Upon information and belief, Registrant did not have any intent to use THE RESORT ROME as a trademark, and is no longer using the mark and has no intention of recommencing use of the mark.

COUNT ONE

Prior Rights and Confusingly Similar

24. Petitioners repeat and reallege the allegations contained in paragraphs 1- 23 above as if the same were set forth at length herein.

25. Petitioners use of THE GLORY OF ROME, ROMAN PLAZA, CAFÉ ROMA, and ALL ROADS LEAD TO ROME, among others, (the “ROME MARKS”) dates back to at least as early as November 16, 1998, long prior to the May 2000 first use date and the May 20, 2003 registration date for Registrant’s ROME mark.

26. The designation THE RESORT ROME is similar to Petitioners’ ROME MARKS and, as such, is likely to cause confusion and mistake and to deceive, with consequent injury to Petitioners, the trade and the public.

27. Registrant's services are nearly identical to Petitioners' services which they have marketed and offered for sale and are currently marketing and offering for sale under Petitioners' ROME MARKS.

28. Registrant's THE RESORT ROME designation is likely, when used in connection with Registrant's services, to cause confusion and mistake and to deceive, with consequent injury to Petitioners, the trade and the public.

29. Further registration and use of Registrant's THE RESORT ROME mark for "business management and development of casinos, resorts, hotels, convention centers, entertainment and tourist destinations and amusement theme attractions, and products merchandising services for others" is likely to confuse and deceive consumers into thinking that Registrant's services are affiliated with, sponsored by, or connected with Petitioners.

30. Petitioners are being damaged by the registration of THE RESORT ROME on the Supplemental Register because such registration supports and assists Registrant in the confusing and misleading use of Registrant's designation, and gives color of exclusive statutory rights in Registrant in violation and derogation of the prior superior rights of Petitioners.

COUNT TWO

Registration is Void Ab Initio

31. Petitioners repeat and reallege the allegations contained in paragraphs 1- 30 above as if the same were set forth at length herein.

32. Registrant did not use the designation THE RESORT ROME as a trademark, as set forth in §45 of the Lanham Act, 15 U.S.C. §1127.

33. Registrant, at no time, had a bona fide intent to use THE RESORT ROME in U.S. commerce, as set forth in §45 of the Lanham Act, 15 U.S.C. §1127.

34. Due to its failure to use the mark as proscribed in the Lanham Act, Registrant committed fraud on the Trademark Office and thus, Registration No. 2,718,270 should be canceled.

35. Petitioners are being damaged by the registration of THE RESORT ROME on the Supplemental Register because such registration supports and assists Registrant in the confusing and misleading use of Registrant's designation, and gives color of exclusive statutory rights in Registrant in violation and derogation of the prior superior rights of Petitioners.

COUNT THREE

The Registration Has Been Abandoned

36. Petitioners repeat and reallege the allegations contained in paragraphs 1- 35 above as if the same were set forth at length herein.

37. Registrant attached its website, resortscenter.com as a specimen of use of THE RESORT ROME.

38. Registrant's website is currently not active.

39. Registrant is not currently using THE RESORT ROME and has no intent to resume use of ROME.

40. Registrant has abandoned its rights in and to THE RESORT ROME and pursuant to §45 of the Lanham Act, 15 U.S.C. §1127, Registrant's mark should be deemed abandoned and removed from the Register.

WHEREFORE, Petitioners request that this Petition to Cancel be granted, in its entirety, and that Registration No. 2,718,270 be cancelled.


