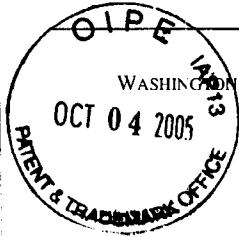

Swisspartners Investment Network AG, a corporation of Switzerland, located and doing business at Am Schanzengraben 23, 8002 Zurich, Switzerland, believes that it is or will be damaged by Registration No. 2,782,790, issued on the Principal Register on November 11, 2003 to Respondent for the mark LIFEBRIDGE (stylized) in connection with "estate planning services." Petitioner hereby petitions for a partial cancellation of said registration pursuant to Section 18 of the Trademark Act.

As grounds for this petition, Petitioner alleges:

1. Petitioner has adopted the marks LIFEBRIDGE and LIFEBRIDGE and Design in connection with "insurance services, namely, life insurance underwriting, brokerage, claims administration" and "insurance underwriting, especially services in the field of life insurance," and on October 21, 2003 and August 25, 2004, respectively, filed pending U.S. application serial

No. 78/316,583 and Madrid Protocol application serial no. 79/006,180, therefore, in the U.S. Patent and Trademark Office.

2. To the best of Petitioner's knowledge, Respondent is the current owner of record of Registration No. 2,782,790 for the mark LIFEBRIDGE (stylized) for "estate planning services" and respondent address is as stated in the attached copy of the registration (Exhibit 1).

3. Respondent's Registration No. 2,782,790 has been cited against Petitioner's pending applications.

4. Upon information and believe, Respondent's estate planning services are informational services provided to professionals with clients, not the public in general. Accordingly, Petitioner seeks a partial cancellation or modification to registration No. 2,782,790 by limiting the services specified therein to the appropriate class of purchaser pursuant to Section 1068 of the Lanham Act.

Therefore, this Petitioner, Swisspartners Investment Network AG, believes that it is being and will continue to be damaged by the continued registration of the LIFEBRIDGE (stylized) as foresaid and prays that said registration be partially cancelled as requested. Petitioner hereby appoints P. Jay Hines, a member of the law firm of Baker & Hostetler LLP and a member of the Bar of the District of Columbia, to prosecute this cancellation proceeding and transaction all business in and before the U.S. Patent and Trademark Office in connection therewith.
