On March 20, 2009, the Trademark Trial and Appeal Board (the "Board") issued an order (the "Second Show Cause Order") accepting the response of TTT Moneycorp Limited ("Registrant") to the Board's first Show Cause Order of April 26, 2007. As part of the Second Show Cause Order, the Board required Registrant to show cause why judgment should not be entered against it with respect to certain services deleted when Registrant did not file a Section 8 affidavit for the mark and services listed in Reg. No. 2463593.

On April 7, 2009, Registrant filed a response addressing the show cause issue. The Board has yet to respond or take further action. Pursuant to the final page of the Board's Second Show Cause Order, proceedings remain suspended. *See also* TBMP §§ 528.03, 535, 602.02(b). Please advise if Registrant can provide further information or assistance to remove the suspension and allow the cancellation action to continue.
