**Discovery and testimony dates are set as indicated below.** In each instance, a copy of the transcript of testimony, together with copies of documentary exhibits, must be served on the adverse party within thirty days after completion of the taking of testimony. Trademark Rule 2.125.

Discovery period to open: **November 15, 2005**

Discovery period to close: **May 14, 2006**

30-day testimony period for party in position of plaintiff to close: **August 12, 2006**

30-day testimony period for party in position of defendant to close: **October 11, 2006**

15-day rebuttal testimony period to close: **November 25, 2006**

Briefs shall be filed in accordance with Trademark Rule 2.128(a) and (b). An oral hearing will be set only upon request filed as provided by Trademark Rule 2.129.
