**RESPONSE TO TTAB COMMUNICATION DATED FEBRUARY 14, 2006**

This paper responds to the communication dated February 14, 2006 transmitted from the Trademark Trial and Appeal Board. In the communication, the Trademark Trial and Appeal Board requested further information to support Venable's Withdrawal as Attorney of Record and as Domestic Representative (hereinafter the "Withdrawal").

After Withdrawal was filed with Trademark Trial and Appeal Board, Venable LLP, through Andrew C. Aitken, Esq. on behalf of the firm, was requested to proceed with the representation of the Respondent and Registrant, Cantine Caputo S.p.a ("Cantine Caputo"). On January 30, 2006, Venable subsequently filed an Answer to the petition in the above-captioned case.

In view of these circumstances it is submitted that Venable's Withdrawal is rendered moot and Venable specifically consents to the continued representation as attorney of record and as domestic representative in connection with the prosecution of the trademark registration that is the subject of the above referenced Cancellation Proceedings 92045271, and as the attorney of record in the Cancellation Proceeding No 92045271. withdrawn. Venable's continued representation is specifically predicated upon Cantine Caupito's compliance with terms set forth in Venable's engagement letter.
