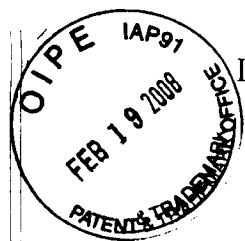

To the COMMISSIONER OF TRADEMARKS:




