**RESPONDENT’S AGREED AND STIPULATED

In support of this motion, Respondent states as follows:

**PROCEDURAL POSTURE**

1. On May 15, 2006, Petitioner filed its Petition for Cancellation of Respondent’s Registered Trademark No. 2987165 (Doc. #1).
2. On May 16, 2006, the TTAB set a due date for forty (40) days after May 16, 2006, or June 25, 2006, in which Respondent is to file an Answer to the Petition. (Doc. #2). As June 25, 2006 falls on a Sunday, Respondent’s Answer would be due on June 26, 2006. See Trademark Rule 2.196.

### **MOTION FOR EXTENSION OF TIME**

3. Respondent hereby moves for an extension of time of fourteen (14) days in which to file an Answer to Petitioner's Petition for Cancellation, or until July 10, 2006.

4. Counsel for Respondent has consulted with counsel for Petitioner who does not object to the relief sought by Respondent.

5. Both Parties have agreed and stipulated to the requested relief as indicated by their counsel's signatures below.

6. Respondent does not file this motion for any improper purpose or undue delay.

WHEREFORE, RESPONDENT RESPECTFULLY moves the TTAB to grant an extension of time of fourteen (14) days from June 26, 2006, or until July 10, 2006, in which to file an Answer to the Petition for Cancellation.




