OPPOSER'S STIPULATED MOTION TO

Petitioner, The Council of the Church of South India Congregations in North America ("the Council"), hereby moves this honorable Board to consolidate the above two proceedings pending before it, Cancellation Proceeding No. 92,045,804 against Reg. No. 2,987,165 and Opposition Proceeding 91,171,614 against Ser. No. 78/707,782. Both proceedings involve disputes relating to the use of the mark CHURCH OF SOUTH INDIA, as used with or without a design logo.

In both proceedings, the parties are the same, the marks are practically identical, the issues are practically identical, and the Motion is made for the purposes of judicial economy.

The attorney of record for the Council, Ms. JoAnne Denison has contacted the attorney of record for Respondent, Church of South India of North America ("CSINA"), Mr. Charles Mudd, and the parties are in agreement as to the consolidation of proceedings.
