REGISTRANT'S FIRST NOTICE OF RELIANCE

Registrant Pro-Football, Inc. ("Registrant") hereby offers into evidence and make of record in the above-caption proceeding the documents and materials set forth below.

On March 14, 2011, Registrant and Petitioners Amanda Blackhorse, Marcus Briggs, Phillip Gover, Jillian Pappan, and Courtney Tsotigh (collectively, "Petitioners" and, with Registrant, the "Parties") filed a Joint Stipulation Regarding Admissibility Of Certain Evidence And Regarding Discovery Issues, in which the Parties agreed that, with certain exceptions, "all evidence submitted with a Notice of Reliance, as well as all deposition transcripts and exhibits thereto submitted by any party, in *Harjo et al v. Pro-Football, Inc.*, Cancellation No. 21,069 (TTAB) ("*Harjo*") shall be admissible in this proceeding unless the Trademark Trial and Appeal Board ruled in *Harjo* that the evidence was not admissible, in which case all arguments as to admissibility are preserved." (# 31, ¶ 1.)

In its May 5, 2011 Order Summarizing Pre-Trial Conference, the Trademark Trial and Appeal Board (the "Board") recognized that such materials "shall admissible in this proceeding by notice of reliance." (# 39 at 5.)¹

On December 23, 2011, the Parties filed under seal a Second Joint Stipulation Regarding Admissibility Of Certain Evidence And Regarding Certain Discovery Issues, in which the Parties agreed "to forego introducing into the record any evidence (including testimony) other than that described [therein] or explicitly permitted in the [first] Joint Stipulation filed with the Trademark Trial and Appeal Board" on March 14, 2011. (# 45, ¶ 16.)

In the same Order, the Board also instructed the Parties "to prepare and file tables summarizing their testimony and other evidence and specifying (1) the probative value of particular facts or testimony and (2) the location in the record of such facts or testimony," and to submit such tables with the Parties' respective briefs. (# 39 at 6-7.) Registrant will provide the requested tables with its brief. Registrant further notes that its Notices of Reliance filed in *Harjo* and submitted herewith provide the general relevance of those materials where necessary, pursuant to TBMP § 704.02 ("The notice of reliance must include a description of the proffered materials and, in some instances, must indicate the relevance of those materials to the case.").

Accordingly, pursuant to the parties' stipulation and 37 C.F.R. § 2.123(b), Registrant hereby files with this First Notice of Reliance the following documents and materials:²
