**PETITIONER'S RESPONSE TO REGISTRANT'S MOTION TO DISMISS**

**Statement of Facts**

The basic facts of this case are straightforward and not in dispute. On February 1, 2006, Petitioner filed U.S. Serial Nos. 78/804,334 and 78/804,683. Both applications were filed under Section 1(b)(intent to use) and seek registration of the marks FAT COBRA CONDOMS and PHAT COBRA CONDOMS, respectively, for use in connection with condoms. See Exhibit A.

Ten days later, Registrant filed a Section 1(a)(use) application seeking registration of the mark COBRA CONDOMS! in connection with retail store and mail order services featuring condoms, adult sexual products, adult movies, personal lubricants and novelty items. See Exhibit B. On September 5, 2006, Registrant was granted the now disputed registration No. 3,139,215. Registrant claimed a date of first use for its registered mark of February 8, 2006; a first use date it has now reiterated and confirmed in its motion. See Motion to Dismiss at ¶ 8.

Further, in co-pending Opposition No. 91175742 (a proceeding initiated by the Registrant opposing the registration of Petitioner's above mentioned mark(s)), the Registrant agreed that a likelihood of confusion existed between Petitioner's mark(s) and the registered mark. Specifically, to quote the Registrant, "Herculinks Corporation have a original signed legal document dated March 29, 2006 from the applicant of Phat Cobra Condoms and Fat Cobra Condom stating that our use of Cobra Condoms!® will confuse consumers and **I fully agree.**" See Opposition No. 91175742 - Notice of Opposition filed Feb. 19, 2007 (*emphasis added*).

Petitioner's arguments follow.

### ARGUMENT

The thrust of Registrant's motion is that there is no likelihood of confusion between its registered mark and Petitioner's mark(s). That argument, of course, is patently false. Indeed, it is directly contradicted by Registrant's ongoing Opposition to Petitioner's mark(s) and the Registrant's own admission therein that the parties "fully agree" that confusion exists as to the marks at issue. See also Motion to Dismiss at ¶ 8. Therefore, ample evidence exists to support Petitioner's claim that a likelihood of confusion exist between the marks.

Concerning priority, it is undisputed that the February 1, 2006 filing date of Petitioner's pending applications predates both the filing date and dates of first use for the registered mark. Therefore, subject only to Petitioner's filing of a Statement of Use, Petitioner's mark(s) will have a priority date that clearly and unquestionably predates the priority dates for the registered mark. See 15 U.S.C. 1057(c). Accordingly, at worst, this matter should be stayed (and not dismissed) until such time as Petitioner files its Statement of Use.

**Conclusion**

Registrant has set forth absolutely no substantive legal or factual basis to support the dismissal of the Petition for Cancellation. Therefore, for all of the above reasons, Petitioner requests that the Registrant's motion to dismiss be DENIED. Such action is respectfully requested.

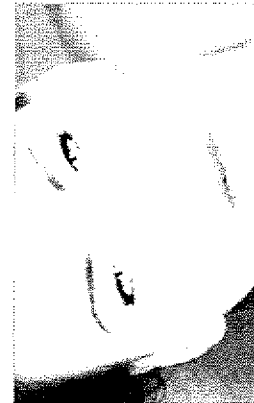
