Chevron Intellectual Property Inc. ("Petitioner"), a corporation duly organized and existing under the laws of the State of Delaware with a principal place of business at 6001 Bollinger Canyon Road, San Ramon, California 94583 believes that it will be damaged by the continued presence on the Register of Registration No. 2,105,612 registered on October 14, 1997 in the name of Next Media I.P. Limited ("Respondent") for the mark NEXT MAGAZINE & Design covering "printed material, namely, magazines in the field of news, including financial and entertainment news, topics of interests, comments, opinions, and advertising" in International Class 16, and hereby petitions to cancel the same.

As grounds for this Petition to Cancel, it is alleged that:

1. Petitioner applied to register the mark NEXT\* for use in connection with "publications and printed matter, namely, magazines and reports in the field of energy, energy companies and energy technology" (U.S. Appl. Ser. No. 78/832,254) in the United States Patent and Trademark Office on March 8, 2006. The Trademark Examining Attorney reviewing the application has refused registration on the ground that Petitioner's mark so resembles U.S. Registration No. 2,105,612 as to be likely to cause confusion, or to cause mistake or to deceive.
  2. Upon information and belief, Respondent, Next Media I.P. Limited, is the record owner of Registration No. 2,105,612 for the mark NEXT MAGAZINE & Design. To the best of Petitioner's information, Respondent's last known address is P.O. Box 71, Craigmuir Chambers Road, Town Tortola, British Virgin Islands.

3. Upon information and belief, Respondent, Next Media I.P. Limited, discontinued use of the alleged mark NEXT MAGAZINE & Design for all goods with an intent not to resume use and, thereby, has abandoned the mark within the meaning of Section 45 of the United States Trademark Act of 1946, 15 U.S.C. § 1127.
4. Given that the alleged mark NEXT MAGAZINE & Design has been abandoned by Respondent, it is subject to cancellation under Section 14 of the United States Trademark Act of 1946 as amended, U.S.C. § 1064.
5. By virtue of the foregoing, Petitioner is now and will be damaged by the continued presence on the Register of U.S. Registration No. 2,105,612 for NEXT MAGAZINE & Design.

WHEREFORE, Petitioner requests that this Petition to Cancel be sustained and that the mark set forth in U.S. Registration No. 2,105,612 be canceled.
