





PETITION TO CANCEL

Registrant.

NO PROBLEM, INC. ("Petitioner"), a California corporation having its principal place of business at 920 North Formosa Avenue, Los Angeles, CA 90046-6702, believes that it is or will be damaged by Registration No. 3,095,122, issued on May 23, 2006, and hereby petitions to cancel the same.

As grounds of this Petition to Cancel, it is alleged that:

1. Petitioner began using the trademark TRAFFIC in connection with clothing, and retail store services for sportswear and accessories in 1982. On or about June 14, 2006, Petitioner filed a trademark application to register the trademark TRAFFIC LOS ANGELES for use in connection with "clothing, shoes, and accessories, retail store services and sales and distribution via the Internet for clothing, shoes, and accessories." The application is currently pending as U.S. Serial No. 78/907,630 (the "Application").

2. On or about November 21, 2006, Petitioner's Application was rejected under Trademark Act 2(d), 15 U.S.C. § 1052(d) on the ground that the trademark TRAFFIC LOS

ANGELES so resembles the trademark TRAFFIC in Registration No. 3,095,122 as to be likely to cause confusion or mistake or to deceive.

3. On information and belief, the TRAFFIC registration is owned by Traffic, Inc. ("Registrant"), a Florida Corporation, with a place of business at 2610 Northwest 3rd Avenue, Miami, FL 33127.

4. On information and belief, Registrant's trademark TRAFFIC was not used in connection with "retail shoe store services" prior to December 31, 1994, its claimed date of first use in interstate commerce.

5. Petitioner is likely to be damaged by continuance of Registration No. 3,095,122 in that the existence of said registration will prevent allowance of Petitioner's Application, and the trademark TRAFFIC is identical to the TRAFFIC trademark previously used in the United States by Petitioner as to be likely, when applied to related goods of Registrant, to cause confusion, mistake, or deception. Accordingly, Petitioner seeks cancellation of U.S. Registration No. 3,095,122.




