

Coen Company, Inc., a California corporation, having offices at 100 Foster City Boulevard, Foster City, California (hereinafter "Petitioner") claims that it will be damaged by Registration No. 2,732,248 for the mark **COENCO REAL AIR MOVER/SILENCER** for "ventilating fans and air circulation systems, comprising a combination of fans, vents, burners, heating units, air conditioning units, temperature sensors and makeup air units, for agricultural,

commercial and industrial use, in Class 11," issued July 1, 2003 (hereinafter "Registrant's Mark").

Petitioner hereby petitions for cancellation of Registration No. 2,732,248. As grounds therefor, Petitioner alleges the following:

1. Since as least as early as March 31, 1959, Petitioner has been continuously and extensively engaged in the business of promoting, offering and distributing goods in interstate commerce, namely, controls for monitoring combustion; and scanners and fiberoptic scanners for monitoring and/or controlling combustion processes in International Class 9, under the mark **COEN**;

2. Since as least as early as March 31, 1959, Petitioner has been continuously and extensively engaged in the business of promoting, offering and distributing goods in interstate commerce, namely, burners, low NOx burners, gas-fired duct burners, oil-fired duct burners and side-fired duct burners, refinery gas duct burners, register-style duct burners, kiln burners, warm-up burners, fuel and air piping and ducts for use with burners and furnaces, scroll burners, process warm-up burners, air heater vessels, gas and fuel igniters for use with burners, side wall igniters, hurricane gas igniters, heavy oil burner retrofits and upgrades, gas burner retrofits and upgrades, tangentially fired burner upgrades, and commercial and industrial furnaces, heaters and boilers in International Class 11, under the mark **COEN**; and

3. Since as least as early as March 31, 1959, Petitioner has been continuously and extensively engaged in the business of promoting, offering and distributing services in interstate commerce, namely, engineering studies and services for others relating to the construction, installation and operation of burners, heaters, ducts and piping for heaters; and turnkey designing, fabrication and supervising installation of burners, heaters, furnaces, heat exchangers and associated piping, ducting and controls for burner, furnace, heater and boiler installations in International Class 37, under the mark **COEN**.

4. The **COEN** mark was the subject of U.S. Trademark Registration No. 0674197, which issued February 17, 1959, reciting the following goods: oil and gas fired

industrial boilerburner apparatus and electric-mechanical controls therefore, in International Class 11.

5. On April 3, 2006, Petitioner filed an application to register its **COEN** mark (hereinafter "Petitioner's mark"), with the goods and services being identified herein in paragraphs 1 through 3. That application was assigned Serial No. 76/657,739 (hereinafter "the '739 Application").

6. On July 1, 2003, Registration No. 2,732,248 was issued to Registrant for the mark **COENCO REAL AIR MOVER/SILENCER**. The date of first use of Registrant's Mark claimed in such registration is July 15, 2002.

7. Long prior to the first use of Registrant's Mark by Registrant, Petitioner's Mark had come to be and is now well known and of great value to Petitioner, and is recognized and relied upon by the trade and the public as identifying Petitioner as the source of Petitioner's goods and services, and to distinguish Petitioner's goods and services from those of others. Petitioner's use of Petitioner's Mark has been exclusive and continuous since prior to the date of first use of Registrant's Mark by Registrant.

8. Petitioner will be damaged by the continuing existence on the Principal Register of Registrant's Mark because such registration is likely to cause confusion with respect to source and origin of the goods and services offered by Petitioner and Registrant under their respective marks; the sponsorship, affiliation or relation between Petitioner and Registrant; and the rights granted Registrant under such registration and the superior rights held by Petitioner in Petitioner's Mark. In addition, the registration of Registrant's Mark gives color of statutory rights to Registrant's Mark, in violation and derogation of the superior rights of Petitioner.

WHEREFORE, Petitioner hereby respectfully requests that this Board cancel Registration No. 2,732,248.

Please charge any necessary fee regarding this Petition to the Deposit Account of Townsend and Townsend and Crew, DAO 20-1430, and credit any overpayment to such deposit account.

WHEREFORE, Petitioner hereby respectfully requests that Registration No. 2,732,248
be canceled in its entirety.


