**MOTION FOR EXTENSION OF TIME
TO ANSWER OR OTHERWISE PLEAD**

NOW COMES the Respondent, Brauhaus Incorporated, by and through its undersigned attorneys, and respectfully requests that the Board grant it an extension of time of thirty (30) days, until March 13, 2009, to answer or otherwise plead to the Petition to Cancel filed by Petitioner, Browhouse Pte Ltd. In support thereof, Respondent states as follows:

1. Until very recently, the parties had been discussing the prospect of settlement.

2. As Respondent has long-explained to Petitioner, it is Respondent's intention to file a motion to dismiss the Petition to Cancel. Now that a settlement of this matter in the near term appears unlikely, Respondent requires additional time to fairly complete and file its anticipated motion to dismiss.

3. This extension, therefore, is not sought for the purposes of delay but to allow Respondent sufficient time to appropriately respond to the Petition to Cancel.

4. Lee Eulgen, counsel for Respondent, has requested Petitioner's counsel to agree to this extension, but Petitioner's counsel has not yet provided its response to the request.

Accordingly, in light of the present deadline to answer or otherwise respond to the Petition to Cancel, the instant motion was necessitated.

WHEREFORE, Respondent, Brauhaus Incorporated, respectfully requests that the Board grant it an extension of time of thirty (30) days, until March 13, 2009, to answer or otherwise plead to the Petition to Cancel.
