**AMENDMENT OF REGISTRATION**

Pursuant to Rule 2.173(b) of the Trademark Rules of Practice, Registrant respectfully requests that the above registration be amended by amending the description of services to add the language "specifically, through the use of simulated models of hospital environments identified as virtual care units for training in the field of patient diagnosis, treatment and care " at the end of the current description of services. The description should now read:

HEALTHCARE EDUCATIONAL SERVICES, NAMELY  
CONDUCTING CLASSES, SYMPOSIUMS, SEMINARS,  
WORKSHOPS, CONFERENCES AND PROGRAMS IN THE  
FIELD OF CLINICAL PATIENT DIAGNOSIS, TREATMENT  
AND CARE, SPECIFICALLY, THROUGH THE USE OF  
SIMULATED MODELS OF HOSPITAL ENVIRONMENTS  
IDENTIFIED AS VIRTUAL CARE UNITS FOR TRAINING IN  
THE FIELD OF PATIENT DIAGNOSIS, TREATMENT AND  
CARE.

This amendment is being made as part of a settlement of Cancellation Proceeding 92054007 pending at the Trademark Trial and Appeal Board concerning this mark. It is respectfully submitted that this amendment does not require republication as the amendment of services narrows rather than broadens the scope of the services claimed.
