Pursuant to the Trademark Trial and Appeal Board's ("Board") Order dated August 1, 2017, Petitioner Intellisphere, LLC and Respondent Engage Healthcare Communications, LLC, hereby report that the civil action which occasioned the suspension of this proceeding, *Engage Healthcare Communications, LLC v. Intellisphere, LLC*, Civil Action No. 3:12-cv-00787 (FLW-LHG) in the United States District Court District of New Jersey (Trenton) is still pending.

The marks at issue in this cancellation proceeding were made at issue in the District Court through Respondent's First Amended Complaint and its allegation that Petitioner has infringed the same; Petitioner subsequently amended its counterclaims in the District Court, and sought a declaratory judgment of non-infringement.


