Answer was due on October 19, 2013. A review of the record shows that an answer has not been filed.

This case now comes up for consideration of petitioner's motion, filed October 22, 2013, for default judgment against respondent for failure to file an answer. The motion is uncontested.¹

Inasmuch as respondent failed to file an answer in this case, and failed to respond to petitioner's motion in any manner, the motion for default judgment is granted. See Trademark Rule 2.127(a). Accordingly, judgment is hereby entered against respondent, the petition for cancellation is
