Outback also requests that its May 25, 2015 Memorandum in Opposition to Registrant’s Motions for Extension be placed under seal pursuant to the Board’s March 9, 2015 supplemental order.

Request for Correction of the Docket Entry for the Board’s May 2, 2015 Decision and Placement Under Seal of Petitioner’s Brief Dated March 25, 2015

In response to Petitioner's Withdrawal of Petition for Cancellation, dated April 28, 2015, the Board issued its May 2, 2015 Decision dismissing the petition to cancel without prejudice. Outback requests that its March 25, 2015 Memorandum in Opposition be placed under seal to effectuate the intentions of the Board set forth in the April 9, 2015 Supplemental Order.

Outback expresses appreciation for the Board's attention to this request and throughout the proceeding. In particular, Outback would like to thank Mr. Baxley and Ms. Matelski for their attention and responsiveness during these proceedings.
