**CONSENTED MOTION TO EXTEND DISCOVERY PERIOD FOR THE SOLE
PURPOSE OF REGISTRANT'S DEPOSITION OF PETITIONER'S EXPERT
WITNESS**

Registrant Boston Scientific Scimed, Inc. ("Registrant"), with the consent of Petitioner Kinamed Navigation Systems, LLC ("Petitioner"), moves (this "Motion") the Board for an order extending the discovery period to and including August 7, 2015 to allow it to take the deposition of Dr. Richard F.
