Registrant, Magic Hat IP, LLC, through its counsel Harter Secrest & Emery LLP, hereby states the following as its Answer to Petitioner Karbach Brewing Co., LLC's Petition to Cancel.

1. Admits that Registrant is the owner of U.S. trademark registration number 2,938,301, and lacks knowledge or information sufficient to form a belief as to the truth or accuracy of the remainder of the allegations and characterizations contained in paragraph 1.

2. Lacks knowledge or information sufficient to form a belief as to the truth or accuracy of the allegations and characterizations contained in paragraph 2.

3. Denies the first sentence of paragraph 3. The second sentence of paragraph 3 states legal conclusions to which no response is required, but to the extent a response is deemed required, Registrant denies knowledge or information as to what Petitioner "believes."

4. Denies each and every allegation and characterization contained in the Petition to Cancel that was not addressed specifically above.

DEFENSE

5. The Petition to Cancel fails to state a claim upon which relief can be granted.

WHEREFORE, Registrant respectfully requests that the Trademark Trial and Appeal Board deny the relief requested in the Petition to Cancel and dismiss this proceeding.
