Counsel for Respondents Q. Original Plastics UG and von Wülfing GmbH & Co. KG. hereby moves this Board for permission to withdraw from his representation of Respondents pursuant to Trademark Rule 2.19(b) and Patent and Trademark Rule 11.116.

1. Respondents have been in arrears with regard to payment of invoices since October 8, 2015, and are now in arrears in the total amount of \$1,969.40.
2. On February 17, 2016 Counsel sent a letter enclosing a statement for services rendered to date and advising that Counsel would not proceed without full payment of the outstanding invoices by May 1, 2016, and an assurance that Respondents would provide prompt instructions regarding this proceeding.

3. Counsel has not received any response to said letter of February 17, 2016.
