P. 42(a), that the Trademark Trial and Appeal Board (the “Board”) consolidate the above captioned proceeding with Opposition No. 91221928 involving Application Serial No. 86/182,052 for the VITAMIN BLUE mark and the accompanying Counterclaim-Petition For Cancellation (involving VITABLUe U.S. Registration No. 2,849,217, U.S. Registration No. 2,885,094 and partial cancellation of U.S. Registration No. 3,074,359) and the Cancellation No. 92062086 involving U.S. Registration No. 4,418,801 for VITAMIN BLUE.


There is an identity of parties in each proceeding, the marks at issue in each proceeding include the VITAMIN BLUE mark and the VITABLUe mark, and the goods at issue in each proceeding are identical. 


