- *Parties are engaged in settlement discussions*
- *On January 2, 2018, the Board issued an order granting consolidation of Opposition No. 91231759, Cancellation No. 92067206, and Cancellation No. 92067178 and subsequently issued a scheduling order on January 17, 2018, adopting the current schedule of parent proceeding Opposition No. 91231759 for all three proceedings, with the Answer due for each proceeding on February 17, 2018. Notwithstanding the consolidation order, the Board indicated that an answer should be filed separately in each proceeding, so this motion is likewise being filed separately for each proceeding. If any future extensions need to be filed in connection with the answer deadline, the parties request that the Board let them know if the Board prefers that the motion be filed only in connection with the parent proceeding (with a caption that names all of the proceedings). The parties confirm that they are actively engaged in settlement discussions and expect to be able to conclude these consolidated proceedings soon. However, the parties request an additional 30 day extension of all deadlines in the proceedings, including but not limited to all pretrial disclosure and trial dates, to allow time for the parties to complete their settlement discussions.*

B & W Group Ltd. has secured the express consent of all other parties to this proceeding for the extension and resetting of dates requested herein.

B & W Group Ltd. has provided an email address herewith for itself and for the opposing party so that any order on this motion may be issued electronically by the Board.
