PETITION FOR CANCELLATION

Petitioner Joshua S. Schoonover (“Petitioner”), states the following for its petition for cancellation of Registration Nos. 2,207,535; and 2,134,652:

1. Petitioner, Joshua S. Schoonover, is an individual having an address at 3656 Ocean Ranch Blvd., Oceanside, CA 92056.

2. Petitioner, through his company REEFLECTION, LLC, is engaged in the manufacture, distribution and sale of clothing and sporting accessories, including: “***Beanies; Belts; Gloves; Caps being headwear; Hats; Hoodies; Pants; Shoes; Shorts; Snow boots; Snow pants; Snowboard gloves; Snowboard jackets; Coats; Snowboard pants; Snowboard trousers; Socks; Sweatshirts; Sweaters; Sweatpants; Tank-tops; Vests; Woven shirts; T-shirts; Footwear; Ski and snowboard shoes and parts thereof (IC 025)***” and “***Snow boards; Snow skis; Snowboard bindings; Snowboards; Harnesses specially adapted for carrying snowboards, skis and skateboards (IC 028)***” (“Petitioner’s Goods”).

3. Petitioner has a bona fide intent to use the marks FOURSQUARE (“the FOURSQUARE mark”) and FORUM (“the FORUM mark”) in interstate commerce in connection with the sale and marketing of Petitioner’s Goods.

4. On April 28, 2017, Petitioner filed application serial no. 87/430,724 (“Petitioner’s FOURSQUARE Application”) for registration of the FOURSQUARE mark in connection with Petitioner’s Goods, namely, “*Caps being headwear; Coats; Footwear; Hats; Jackets; Pants; Shorts; Sweaters; Sweatpants; Sweatshirts; T-shirts; Tank-tops; Vests; Woven shirts*” in International Class 025, which application is presently pending before the USPTO.

5. On September 30, 2017, Petitioner filed application serial no. 87/629,391 (“Petitioner’s FORUM Application”) for registration of the FORUM mark in connection with Petitioner’s Goods, namely, “*Beanies; Belts; Gloves; Hats; Hoodies; Pants; Shoes; Shorts; Snow boots; Snow pants; Snowboard gloves; Snowboard jackets; Snowboard pants; Snowboard trousers; Socks; Sweatshirts; T-shirts; Ski and snowboard shoes and parts thereof*” in International Class 025, and “*Snow boards; Snow skis; Snowboard bindings; Snowboards; Harnesses specially adapted for carrying snowboards, skis and skateboards*” in International Class 028, which application is presently pending before the USPTO.

6. On July 26, 2017, Petitioner received correspondence from the USPTO indicating that Petitioner’s FOURSQUARE Application was refused under Section 2(d) for likelihood of confusion in view of U.S. Reg. No. 2,134,652.

7. On January 09, 2018, Petitioner received correspondence from the USPTO indicating that Petitioner’s FORUM Application was refused under Section 2(d) for likelihood of confusion in view of U.S. Reg. No. 2,207,535.

8. Upon information and belief, Registrant, THE BURTON CORPORATION (“Registrant”) is a corporation formed under the laws of the State of Vermont and has an address of: 80 INDUSTRIAL PARKWAY, BURLINGTON, VT, 05401, USA.

9. Registrant is the holder of U.S. Reg. No. 2,134,652 for the designation “FOURSQUARE” (“the ‘652 Registration”) in International Class 025 for the following goods and services: “*clothing, namely, T-shirts, sweatshirts, tank tops, shirts, sweaters, vests, jackets, pants, sweatpants, shorts, coats; headwear, hats and caps and footwear*” (“Registrant’s FOURSQUARE Goods”).

10. Registrant is also the holder of U.S. Reg. No. 2,207,535 for the designation “FORUM” (“the ‘535 Registration”) in International Class 028 for the following goods and services: “*snowboards, snowboards binding, snowboards leashes and accessories therefor*” (“Registrant’s FORUM Goods”).

11. On information and belief, Registrant has abandoned and discontinued use of the FOURSQUARE and FORUM marks in commerce for more than three years, such abandonment was made with the intent to not use and to not resume use of the FOURSQUARE and FORUM marks, and Registrant has therefore abandoned the rights to Reg. Nos. 2,134,652 and 2,207,535; as such these registrations should be canceled.

12. Petitioner is and will continue to be damaged by Registrant’s continued registration of the FORUM and FOURSQUARE marks because: (i) the Registrant’s ‘652 Registration has been cited against Petitioner’s FOURSQUARE Application, and will continue to block Petitioner’s FOURSQUARE Application for the registration of FOURSQUARE unless cancellation of the ‘652 Registration is ordered; and (ii) the Registrant’s ‘535 Registration has

been cited against Petitioner's FORUM Application, and will continue to block Petitioner's FORUM Application for the registration of FORUM unless cancellation of the '535 Registration is ordered. Therefore, U.S. Registration Nos. 2,134,652 and 2,207,535 are a source of damage and injury to Petitioner.

13. Because a substantial gathering of the facts, evidence, and parties to this action are common as-between the 2,134,652 and 2,207,535 registrations and the issue of legal abandonment of these trademarks, joinder is proper and should be made in a consolidated trademark cancellation proceeding in accordance with 37 CFR § 2.112(b).

WHEREFORE, Petitioner requests that its petition to cancel Registration Nos. 2,134,652 and 2,207,535 be sustained and that the Trademark Trial and Appeal Board grant any and all further relief to Petitioner that the Board finds necessary and just in the circumstances.
