Dear Commissioner:

RH US, LLC (“Petitioner”), a Delaware limited liability company having its principal place of business at 15 Koch Road, Corte Madera, CA 94925, believes that it is and will continue to be injured if the mark in Registration No. 5,097,794 is not canceled, and hereby petitions to cancel the same.

To the best of Petitioner’s knowledge, the name and address of the current owner of the registration is Body Friend Co., Ltd. (“Respondent”), located at Bodyfriend Tower, 139 Dogok-ro, Gangnam-gu, Seoul 06255, Republic of Korea.

The grounds for cancellation are as follows:

1. Petitioner is a home-furnishings company that offers a range of furniture, lighting, textiles, rugs, bathware, décor and outdoor, as well as baby, child, and teen products. By partnering with independent artisans, it produces unique, high-quality lines. Petitioner maintains

galleries and outlets throughout the US and Canada, and also publishes source books showcasing its styles.

PRIORITY

2. Since at least as early as November 2014, and substantially prior to the priority date for U.S. Registration No. 5,097,794, Petitioner has continuously used the THE CLOUD and CLOUD CUBE marks in connection with the sale of its furniture products. Through extensive use and promotion of the THE CLOUD and CLOUD CUBE marks, Petitioner has developed substantial goodwill and consumer recognition of THE CLOUD and CLOUD CUBE as trademarks that uniquely identify its products.

3. Petitioner filed Application Serial No. 87/643,893 for the THE CLOUD mark for “Furniture, namely, chairs, sofas, and ottomans; modular seating system in the nature of seating furniture” in International Class 20 on October 12, 2017, on a use basis, with claimed first use and first use in commerce dates of November 11, 2014. Application Serial No. 87/643,893 has not yet been published.

4. Petitioner owns U.S. Registration No. 5,117,528 for the CLOUD CUBE mark for “Furniture, namely, chairs, sofas, and ottomans; modular seating system in the nature of seating furniture” in International Class 20. The application to register the CLOUD CUBE mark as shown in Registration No. 5,117,528 was filed on January 21, 2016, with claimed first use and first use in commerce dates of November 11, 2014. Petitioner owns the mark covered by this registration, the registration itself, and the goodwill and reputation of the services connected with and symbolized by the mark. Attached hereto as Exhibit A is a true and correct copy of the registration certificate, a current print-out of the Trademark Status & Document Retrieval (“TSDR”) page, and a current print-out of the trademark abstract of title page for U.S. Registration No. 5,117,528.

5. Respondent is the registrant for U.S. Registration No. 5,097,794 for the mark LA CLOUD for “Furniture; cabinetwork; furniture of metal; wooden beds; office furniture; easy chairs; massage tables; mattress; Korean cushions (bangsuk); pillows; air mattresses, not for

medical purposes; bed pillows; cushions; bed and mattress” in International Class 20 and for “Wholesale store services featuring furniture; retail store services featuring furniture; wholesale store services featuring bed vibrators; retail store services featuring bed vibrators; retail store services featuring bed and mattress; wholesale store services featuring bed and mattress” in International Class 35. This registration matured from a U.S. designation from International Registration No. 1,280,372, which has a registration date of October 14, 2015.

6. On information and belief, Respondent did not use the LA CLOUD mark in the United States in connection with the goods and services included in U.S. Registration No. 5,097,794 prior to the filing date for the international registration.

7. Petitioner has used the THE CLOUD and CLOUD CUBE marks in connection with its furniture goods since well prior to the priority date for Respondent’s LA CLOUD registration.

LIKELIHOOD OF CONFUSION

8. Respondent’s LA CLOUD mark is legally identical to Petitioner’s THE CLOUD mark, as “la cloud” means “the cloud” in French, Spanish, and Italian, among other languages. In this case, the English translation is unambiguously literal and direct, and therefore the doctrine of foreign equivalents should be applied. *See, e.g., In re Aquamar, Inc.*, 115 U.S.P.Q.2d 1122 (T.T.A.B. 2015). The similarities in sight and sound, coupled with the identical meaning, between THE CLOUD and LA CLOUD is likely to lead consumers to erroneously believe that Respondent’s goods and services are offered by or associated with Petitioner.

9. Respondent’s LA CLOUD mark is so substantially similar in sight, sound, meaning, and commercial impression to Petitioner’s CLOUD CUBE mark as to be likely to cause confusion, or to cause mistake, or to deceive. CLOUD is the dominant element in both Respondent and Petitioner’s marks. Therefore, the similarity between CLOUD CUBE and LA CLOUD is likely to lead consumers to erroneously believe that Respondent’s goods and services are offered by or associated with Petitioner.

10. On information and belief, Respondent's furniture goods and retail store services featuring furniture to be offered under the LA CLOUD mark encompass and are competitive with Petitioner's furniture goods under the THE CLOUD and CLOUD CUBE marks.

11. On information and belief, Respondent offers and will continue to offer goods and services under the LA CLOUD mark to the general public and to organizations who are likely already familiar with Petitioner's THE CLOUD and CLOUD CUBE furniture goods.

12. On information and belief, Respondent offers and will continue to offer its goods and services under the LA CLOUD mark through channels of trade that overlap with those used by Petitioner to offer its furniture goods under the THE CLOUD and CLOUD CUBE marks.

13. The U.S. Patent & Trademark Office has cited Respondent's Registration No. 5,097,794 against Petitioner's pending Application Serial No. 87/643,893 for the THE CLOUD mark as a basis for its refusal of the THE CLOUD mark under Section 2(d) due to the likelihood of confusion between the marks.


14. In view of the fact that Respondent's LA CLOUD mark is legally identical to Petitioner's THE CLOUD mark under the doctrine of foreign equivalents and so substantially similar to Petitioner's CLOUD CUBE mark; that Respondent's LA CLOUD goods and services encompass and are competitive with Petitioner's THE CLOUD and CLOUD CUBE goods; and that the customers and trade channels for Respondent's goods and services and Petitioner's goods are and will continue to be the same or overlapping, Respondent's LA CLOUD mark is likely to cause confusion with Petitioner's THE CLOUD and CLOUD CUBE marks, or to cause mistake, or to deceive as to the origin, source, or sponsor of Respondent's goods and services. Petitioner therefore has been injured, and will continue to be injured, by the continuing registration of Respondent's LA CLOUD mark.

WHEREFORE, Petitioner prays that Registration No. 5,097,794, currently registered to Respondent, be canceled.
