PETITION FOR CANCELLATION

Even Responsible Finance, Inc. (“Even”) believes it is now and will continue to be damaged by Apricot Square Limited’s (“Respondent”) continued registration of the trademark EVEN, as shown in Registration No. 4683201, (“Respondent’s Mark”), and hereby petitions to cancel said registration.

The grounds for this petition are as follows:

1. Respondent is the owner of U.S. Registration No. 4683201 for the Respondent’s Mark for “Mobile phone and mobile hand-held devices, namely, smart phones for use in electronic payments and the transfer of monetary sums; credit cards, debit cards, charge cards, smart cards, namely, cards with an embedded microprocessor, cheque guarantee cards, all magnetically encoded and all used in relation to the electronic transfer of funds and other financial transactions; pre-payment cards, namely, magnetically encoded cards with monetary value; electronic payment cards, namely, magnetically encoded credit cards, debit cards, charge cards, smart cards and cheque guarantee cards; encoded payment cards, namely, magnetically encoded credit cards, debit cards, charge cards, smart cards and cheque guarantee cards;

computer software for the issuing of pre-paid and stored value cards; electronic cards bearing pre-paid and stored value being electronically encoded credit cards, debit cards, charge cards, smart cards, cheque guarantee cards; cards and other apparatus, namely, electronically encoded credit cards, debit cards, charge cards, smart cards and cheque guarantee cards, all used in the electronic transfer of funds and other financial transactions” (“Respondent’s Goods”). A printout from the TSDR, evidencing the current status and ownership of this registration, is attached as **Exhibit A**.

2. Respondent filed the application to register Respondent’s Mark on September 25, 2013, and does not claim a date of first use in commerce, as the application was based on a Section 66(a) filing basis.

3. On July 18, 2017 (with a priority date of January 23, 2017), Petitioner filed U.S. trademark application Serial Nos. 87531713, 87531711, and 87531710 to register the mark EVEN (“Petitioner’s Mark”) in connection with: “application service provider (ASP) featuring software for financial planning and financial management; Application service provider (ASP) featuring software for use in the fields of financial services, financial management and financial planning; online computer services for financial planning and financial management; online computer services in the fields of financial services, financial management, and financial planning” for Serial No. 87531713; “financial services; financial management; financial planning” for Serial No. 87531711; and “computer software and mobile application software for financial planning and financial management; computer software and mobile application software for use in the fields of financial services, financial management and financial planning; computer software and mobile application software for the collection, editing, monitoring,

managing, organizing, modifying, bookmarking, aggregating, analyzing, reporting, transmission, storage and sharing of data, documents, and information; computer software and mobile application software for providing users the ability to create, modify, edit, share, manage, store, and view electronic content, data and information over the Internet or other communications network” for Serial No. 87531710 (together, “Petitioner’s Goods and Services”). A printout from the TSDR, evidencing the current status and ownership of these applications, is attached as **Exhibit B**.

4. In Office Actions dated October 18, 2017, the Trademark Office has preliminarily refused registration of Petitioner’s U.S. trademark application Serial Nos. 87531713, 87531711, and 87531710, based, in part, on a perceived likelihood of confusion with U.S. Registration No. 4683201.

5. Upon information and belief, Respondent has discontinued use of Respondent’s Mark with an intent not to resume such use, and Respondent has abandoned the Respondent’s Mark.

6. Cancellation of Registration No. 4683201 on the basis of abandonment is proper in accordance with 15 U.S.C. §1064 (3).

7. Continued registration of Respondent’s Mark in connection with Respondent’s Goods is causing harm to Petitioner by interfering with Petitioner’s ability to register and protect its EVEN trademark in connection with Petitioner’s Goods and Services.

WHEREFORE, Petitioner believes that it is, and will continue to be, damaged by the registration of Respondent's Mark and that Respondent's Mark has been abandoned, and prays that said registration be canceled.
