**PETITIONER’S MOTION TO EXTEND TIME TO FILE RESPONSE
TO REGISTRANT’S MOTION TO DISMISS, WITH CONSENT**

Pursuant to TBMP § 509.01, Petitioner, Whirlpool Corporation, respectfully moves for an extension of time, until July 5, 2019, to file a Response to the Registrant’s Motion to Dismiss the Petition to Cancel in this proceeding. The Registrant has given its consent to this Motion.

Because this Motion is being filed prior to the due date to file the Response, only a showing of good cause is required. TBMP § 509.01. There is good cause for this Motion, as explained herein.

The Board in its Order of March 11, 2019 granted the Petitioner’s motion for an extension of time to file a Response to the Registrant’s Motion to Dismiss until May 6, 2019. The Registrant has consented to a further extension of time for the Petitioner to file its Response, until July 5, 2019 (60 days from the filing date of the instant motion). The good cause for this motion is that the parties are discussing settlement. A draft agreement was prepared by Petitioner and provided to Registrant for consideration, and then Registrant made a counteroffer, which the Petitioner is now considering. This requested extension of time is not necessitated by the Petitioner’s lack of diligence or unreasonable delay.

WHEREFORE, Petitioner requests that it be granted an extension of time to file its Response to the Registrant's Motion to Dismiss, until July 5, 2019.
