PETITION TO CANCEL REGISTRATION NO. 4342761

Cambridge Innovation Capital Plc, a U.K. Public Limited Company with an address at Hauser Forum, 3 Charles Babbage Road, Cambridge CB3 0GT, United Kingdom, (“Petitioner”) believes that it is and will be damaged by Registration No. 4342761 and hereby petitions to cancel the same.

As grounds for this Petition, it is alleged:

1. Petitioner is the applicant in U.S. Trademark Application Serial No. 79/191714 (IR 1309050) for the mark CAMBRIDGE INNOVATION CAPITAL for, “Business consultancy and advisory services” in Class 35 and “Financial affairs; monetary affairs; investment services; investment consultations; investment research; providing information, consultancy and advice in the field of financial investment and funding; providing funding to businesses; providing financial analysis of businesses for funding purposes; providing financial advice to businesses” in Class 36.

2. The U.S. Patent and Trademark Office has issued a refusal of registration of Petitioner's mark based on likelihood of confusion with Registration No. 4342761 for the mark INNOVATION CAPITAL covering "Business consulting; business risk assessment; business feasibility studies; business process management consulting; business data analytics; business data collection; business data integration; business management consulting with relation to the use of analytic and statistic models for the understanding and predicting of consumers, business, market trends and actions; business acquisition consultation; economic forecasting and analysis; strategic analysis; strategic valuation; strategic consulting; strategic planning; business consulting services in the field of mergers and acquisitions; business consulting services in the field of research and development; advisory services with regard to business planning, business analysis, business management, business organization and competitive capabilities" in Class 35 and "Corporate venture capital advisory services; venture capital advisory services; financial services, namely, financial advisory and financial consulting services in the field of corporate venture capital" in Class 36 (hereinafter "the Registered Mark").
3. Upon information and belief, Registrant is not currently using, has no intent to resume use, and has consequently abandoned use of the Registered Mark in the United States in connection with the services listed in the subject registration.
4. The Registrant is listed in the Massachusetts Secretary of the Commonwealth, Corporations Division database as "dissolved" by involuntary dissolution as of June 30, 2016. See attached Exhibit A.
5. The telephone number listed in Registrant's website, 617-247-6300 currently is answered "Welcome to Dine Out With Us."


6. Upon information and belief, the mark INNOVATION CAPITAL shown in Registration No. 4342761 is no longer in use in connection with the services listed in that registration, and has therefore become abandoned.
7. If the Registrant is permitted to retain Registration No. 4342761, a cloud will be placed on Petitioner's Application, on the mark that is the subject of Petitioner's Application Serial No. 79/191714, and on Petitioner's right to use, register and expand the use of that mark. Continued registration of the Registered Mark would thus be a source of damage and injury to the Petitioner.

WHEREFORE, Petitioner respectfully requests that this Petition be granted and that Registration No. 4342761 be cancelled.
