#### PETITION TO CANCEL

Clark Equipment Company ("Petitioner"), a Delaware corporation with an address at 250 East Beaton Drive, West Fargo, North Dakota 58078, believes that it is damaged by continued registration of the BOBCAT mark ("Registrant's Mark") in Registration No. 4684661 (the "Registration") owned by Xplore Technologies Corporation of America<sup>1</sup> ("Registrant") and hereby petitions to cancel it.

The grounds for cancellation are as follows:

- 1. Upon information and belief, Registrant is a Delaware corporation with an address at 14000 Summit Drive, Suite 900, Austin, Texas, 78746.
- 2. On July 3, 2014, Registrant filed to register the Registrant's Mark for "Tablet computers; Computer docking stations; Computer handles; and Computer battery packs" in Class 9 ("Registrant's Goods").
  - 3. The Registration alleges a date of first use of June 24, 2014, and a date of first

use in commerce of June 24, 2014.

- 4. Registrant advertises that its goods are for rugged work environments, including construction work sites. A brochure for Registrant's Goods that displays photographs of Petitioner's tablet being used in this environment, including a photo of a tablet on the seat of a skid-steer loader overlaid with the word "BOBCAT" represented against an orange background, is attached as Exhibit A.
- 5. Petitioner does business as Bobcat Company, and has used the trademark BOBCAT ("Petitioner's Mark") in connection with compact construction equipment, components, parts, and accessories since at least as early as 1958 when it introduced the first skid-steer loader to the market.
- 6. Petitioner uses the BOBCAT Logo, represented in a custom orange-red shade called "Bobcat Orange," which is also used throughout its branding and as a part of its distinctive color scheme for its machines and equipment.



- 7. Over the years, the BOBCAT machine has undergone countless improvements: Electronic controls replaced manual controls; computer software replaced electronic switches and circuitry; and touch screens will soon replace visual display screens.
- 8. Since at least as early as 2001, and continuously since that time, Petitioner has used the Petitioner's Mark in connection with computer software for its machines.
- 9. Since at least as early as 2007, and continuously since that time, Petitioner has used the Petitioner's Mark in connection with display screens for its machines.
  - 10. Since at least as early as February, 2014, and continuously since that time,

Petitioner has used Petitioner's Mark in connection with interactive screens for its machines.

- 11. Petitioner's display/touch screens are sold installed on the machine, but are also sold as a replacement part.
- 12. Petitioner's machines incorporating its display/interactive screens and software ("Petitioner's Goods") are sold through a dealer network, and replacement parts are likewise sold through this network as well as online.
- 13. Customer's for Petitioner's Goods are those who work in the fields of construction, site development and excavation, landscape, maintenance, and government and municipalities.
- 14. Petitioner owns common law rights based on its prior and continuous use of BOBCAT in connection with Petitioner's Goods as of the dates of first use recited in Paragraphs 8-10 above.
- 15. Petitioner owns the registrations for Petitioner's Mark listed in the chart below (the "Petitioner's Registrations"). Printouts of the current status and title of Petitioner's Registrations from the USPTO's Trademark Status & Document Retrieval (TSDR) database are attached as Exhibit B.

- 16. Petitioner's Registrations have not been canceled, are valid, and are in full force and effect.
- 17. Petitioner's Registrations are *prima facie* evidence of Petitioner's exclusive right to control use of Petitioner's Mark in commerce.
- 18. Petitioner has used Petitioner's Mark extensively and made substantial sales of Petitioner's Goods, and machines and equipment incorporating Petitioner's Goods, under

Petitioner's Mark. As a result of this use and promotion, Petitioner's Mark has developed and represents valuable goodwill inuring to the benefit of Petitioner.

- 19. Petitioner has priority with respect to the marks at issue because it used and registered Petitioner's Mark before Registrant filed to register Registrant's Mark and before the first use dates alleged therein, September 24, 2014.
- 20. Petitioner's Mark is well-known and famous, particularly in the construction, landscape, and maintenance industries.
  - 21. Registrant's Mark and Petitioner's Mark are identical.
- 22. Registrant's Goods are highly similar and at least related to Petitioner's Goods. In particular, Registrant's computer battery packs are highly similar to Petitioner's batteries for off-road machinery; Registrant's tablet computers are very closely related to Petitioner's display and interactive screens; and Registrant's computer peripherals are very closely related to Petitioner's computer software.
- 23. Registrant's Goods and Petitioner's Goods are sold through the same trade channels, and to the same customers.
- 24. Based on the identity of the marks and the overlap in the goods, trade channels, and customers for the parties' goods, as well as the strength of Petitioner's Mark, consumers are likely to believe that Registrant's Goods originate from Petitioner or are otherwise endorsed, sponsored, or approved by Petitioner, resulting in a likelihood of confusion in the marketplace and damage to Petitioner.
- 25. The continued registration of Registrant's Mark will cause irreparable damage to Petitioner under Section 2(d) of the Lanham Act, 15 U.S.C. § 1052(d).
  - 26. The continued registration of Registrant's Mark unjustly precludes Petitioner

from logical expansion of its mark to new technology and components to support and interface

Petitioner's machines and equipment and compete in the industry by marketing and selling such
goods.

WHEREFORE, Petitioner requests cancellation of the Registration.
