Lagom Kitchen Company (“Lagom”), a company existing under the laws of the state of Delaware with an address of 12308 Darlington Avenue, Los Angeles, CA 90049, believing it will be damaged by the continued registration of the Mark, and through its attorneys, hereby petitions to cancel the Registration.

The grounds for cancellation are as follows:

COUNT I
ABANDONMENT

1. Petitioner is a company in the business of manufacturing and selling cookware, dinnerware, and housewares.
2. Upon information and belief, and after diligent investigation, Petitioner believes that as of today, and for at least the last three years, Registrant has abandoned the Mark and has no intent to resume use.
3. Upon information and belief, Registrant does not use the Mark in association with any of the goods listed in the Registration.
4. The continued presence of the Registration on the federal trademark register constitutes an obstacle to Lagom's intended use of the term "Ours." The Registration, thus, is causing injury and damage to Lagom.

WHEREFORE, Petitioner prays that cancellation be entered and be sustained in favor of the Petitioner.
