**PETITION FOR CANCELLATION**

The Hain Celestial Group, Inc., (hereinafter "Petitioner"), a United States Delaware corporation with an address at 1111 Marcus Avenue, Lake Success, New York 11042 believes it is damaged and will continue to be damaged by U.S. Registration No. 5,082,314, issued November 15, 2016, for the mark PAVING THE WAY TOWARD A HEALTHIER WAY OF LIFE in Class 35 (the "Registration"), registered to Charles Paul (hereinafter "Registrant"), a United States individual with an address at 8751 North 117<sup>th</sup> East Avenue, Suite J, Owasso, OK 74055, and hereby petitions for cancellation of the registration, pursuant to 15 U.S.C.A. §1064.

As grounds in support of its petition for cancellation, Petitioner asserts as follows:

1. Petitioner is the owner of U.S. Trademark Application Ser. No. 88039395 for A HEALTHIER WAY OF LIFE, filed on July 16, 2018 covering "*Advertising, business management, business administration, office functions; Promotion, advertising and marketing of on-line websites; Providing services of online and offline retail sales, wholesale, distribution, marketing, consultancy; import, export of food products; retail store and mail order services featuring food and beverages for consumption on and off premises; Advertising and marketing services provided by means of indirect methods of marketing communications, namely, social media, search engine marketing, inquiry*

*marketing, internet marketing, mobile marketing, blogging and other forms of passive, shareable or viral communications channels; on-line customer-based social media brand marketing services; Distribution and dissemination of advertising materials, namely, printed material, brochures and samples; Charitable services, namely, organizing and conducting volunteer programs and community service projects for employee participation” in Class 35; (the “Application”). See Exhibit A, attached hereto.*

2. Petitioner is being harmed by the Registration because the PTO Examining Attorney has refused the Application for registration on grounds that the Application is likely to be confused with the prior pending Registration. Priority and Likelihood of Confusion Trademark Act Section 14 (1) and 2(d).

3. Upon information and belief, Registrant is not currently and has not used his trademark PAVING THE WAY TOWARD A HEALTHIER WAY OF LIFE via interstate commerce. The Registrant is the owner of a vape store called Palm Beach Vapors selling nicotine juice and CBD products in the state of Oklahoma only. No use of trademark has been found in commerce before application, amendment to allege use, or statement of use was filed. Trademark Act Section 14 (1) and 1 (a), (c), and (d). See Investigation Report attached hereto as Exhibit B.

4. Petitioner is damaged and will continue to be damaged because Registrant's continued registration of the PAVING THE WAY TOWARD A HEALTHIER WAY OF LIFE mark stands as a bar to Petitioner's ability to federally register and protect its mark A HEALTHIER WAY OF LIFE.

5. Upon information and belief, Registrant is committing Fraud on the USPTO. Trademark Act Section 14 (3); In re Bose Corp., 580 F.3d 1240, 91 USPQ2d 1938 (Fed. Cir. 2009)

**WHEREFORE**, Petitioner prays that this Petition for Cancellation of Registration No. 5,082,314 be granted, resulting in judgment entered against Registrant effecting the cancellation of the Registration.

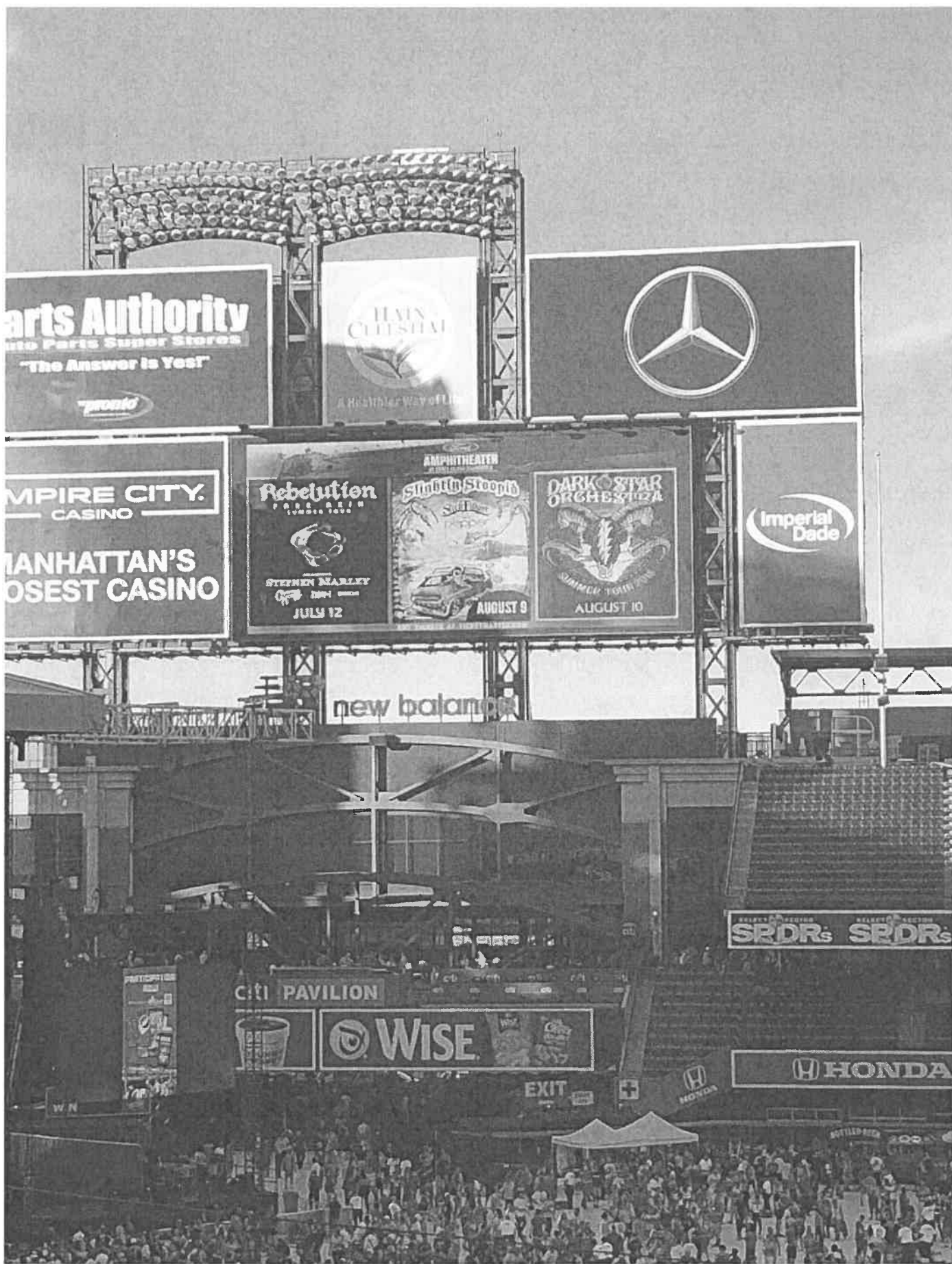

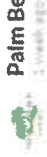

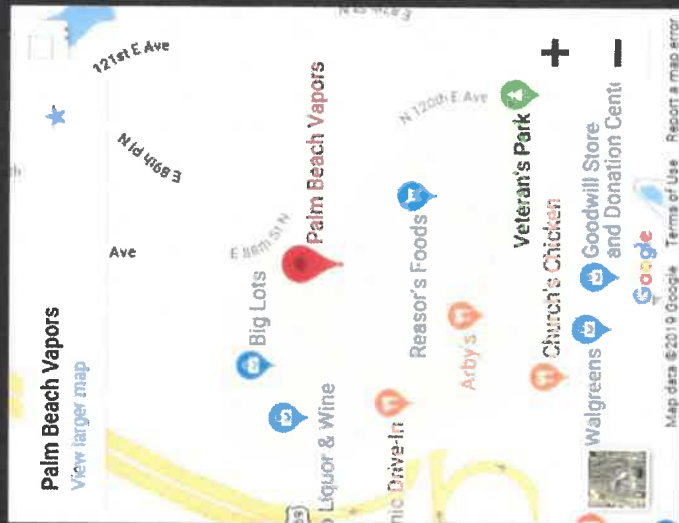
