PETITION FOR CANCELLATION

FRC Balance LLC ("Petitioner") believes that it will be damaged by the continued registration of U.S. Registration No. 4,503,098 for the word mark TRUE CRAFTED PIZZA, owned by Stonecrest Pizza #1 LLC ("Respondent"). Petitioner hereby petitions to cancel this registration on the basis that Respondent's continued registration and use of TRUE CRAFTED PIZZA are likely to cause confusion with Petitioner's registration and use of TRUE FOOD® and other TRUE-based marks.

In support of its Petition for Cancellation, Petitioner states the following:

<u>The Parties</u>

1. Petitioner is an Arizona limited liability company with its principal place of business at 4455 E. Camelback Rd., Suite A115, Phoenix, Arizona 85018.

2. Petitioner has created restaurants under the brand TRUE FOOD®.

3. On information and belief, Respondent is a North Carolina limited liability company with its principal place of business at 7828 Rea Road, Suite F, Charlotte, North Carolina 28277.

Petitioner's Registration and Use of Its Marks

4. Petitioner owns federal registrations for the following marks for or incorporating TRUE FOOD, among others. True and correct copies of these registrations from the TESS database, showing their current status and title, are attached as **Exhibit 1**.

5. Petitioner also has common law rights in TRUE alone and other TRUE-based marks, including, without limitation, BE TRUE and EAT TRUE, in connection with its restaurant services.

6. Collectively, all of Petitioner's registered and common law TRUE-based marks shall be referred to herein as the "TRUE Marks."

7. Petitioner has used the federally registered TRUE Marks in connection with Petitioner's restaurants since at least as early as October 2008.

8. Petitioner has been building its brand geographically and has been expanding from Arizona to other states ever since the first TRUE FOOD® restaurant opened.

9. As a result of Petitioner's efforts, there are already over twenty-one TRUE FOOD® restaurants open in Arizona, California, Colorado, Florida, Georgia, Illinois, Maryland, Pennsylvania, Tennessee, Texas, and Virginia. There are concrete plans to open additional locations in Georgia, Florida, Missouri, Louisiana, Nevada, Virginia and Texas in 2019, as well as developing plans, which are not yet concrete, to have a Charlotte, North Carolina location by sometime in 2020.

10. TRUE FOOD® has been one of the most successful new brands in the country since its introduction in October 2008.

11. TRUE FOOD® was named a "top emerging brand" of 2018. Oprah Winfrey announced in 2018 that she was making a significant equity investment in the chain.


12. TRUE FOOD® restaurants feature healthy food and drink on the menu, including, but not limited to, various types of pizza.

13. Petitioner's pizzas have long been featured in third-party articles, blog posts and reviews including with use of TRUE alone, on server uniforms, as in the example promoting pizza shown below.

14. Petitioner has also long featured its pizzas on its website. Here, for example, is a screenshot from the home page of <u>www.truefoodkitchen.com</u> from 2011, where a picture of Petitioner's pizza was one of the five repeating images on its homepage.



15. Petitioner has also long regularly featured its pizzas on its social media. Here are representative screenshots from Petitioner's Facebook presentations from 2011, 2012 and 2013, all posted before Respondent's date of filing for its Registration of TRUE CRAFTED PIZZA and before Respondent's date of first use of TRUE CRAFTED PIZZA.





16. Petitioner offers both in-dining and take-out at its TRUE FOOD® restaurants.

17. Petitioner has used TRUE alone, as well as in a number of different phrases, such as TRUE INSIDER, SHOP TRUE, LIVE TRUE, TRUE YOU, EAT TRUE, BE TRUE, STAY TRUE, GIVE THE GIFT OF TRUE, SHOW THE TRUE YOU, ALL THINGS TRUE, and BE TRUE TO YOURSELF, among others, to promote its restaurants and to encourage others to eat at TRUE FOOD®.

18. Petitioner's customers regularly refer to Petitioner's restaurants alternatively as"TRUE", "TRUE FOOD" or "TRUE FOOD KITCHEN."

Petitioner has expended substantial time and resources in marketing its TRUE
 FOOD® restaurants and building consumer recognition in the TRUE Marks.

20. Petitioner has extensively marketed its TRUE FOOD® restaurants in various marketing channels, including on the Internet and through various social media platforms.

21. As a result of Petitioner's significant efforts to develop the reputation of the TRUE Marks, there is widespread and growing recognition of the TRUE Marks among consumers.

22. Petitioner has taken steps to enforce its rights against third-party users of marks that are likely to cause confusion with the TRUE Marks.

Respondent's Registration and Use of TRUE CRAFTED PIZZA

23. Respondent is the owner of U.S. Registration No. 4,503,098 for the word mark TRUE CRAFTED PIZZA covering "pizza; take-out pizza" in Class 30 and "restaurant services; take-out restaurant services; catering services" in Class 43 (the "Registration").

24. Respondent filed its application for TRUE CRAFTED PIZZA on an intent-to-use basis on March 4, 2013 and the Registration issued on March 25, 2014.

25. Respondent claims a date of first use of May 16, 2013.

26. On information and belief, Respondent was on actual notice of Petitioner's use and registration of one or more of its TRUE Marks prior to filing Respondent's application for TRUE CRAFTED PIZZA.

27. Respondent currently uses its TRUE CRAFTED PIZZA mark in connection with a single-location pizza restaurant in the Charlotte, North Carolina area.

28. Like Petitioner, Respondent focuses on community and advertises that it "begin[s] with the finest ingredients and craft[s] them together."

29. Like Petitioner, Respondent markets its restaurant in various marketing channels, including on the Internet and through various social media platforms.

30. On information and belief, Respondent's TRUE CRAFTED PIZZA mark, as it is used on Respondent's website and social media, as well as on signage, uniforms and menus at Respondent's restaurant, features TRUE as the predominant element, as shown below.



31. On information and belief, by design, the TRUE portion of TRUE CRAFTED PIZZA, as it is used by Respondent on the Internet and at its restaurant location, has so much more prominence than any other element, such that the initial commercial impression of consumers will be centered on TRUE, rather than on the mark as a whole.

32. On information and belief, because TRUE appears so much larger than CRAFTED PIZZA on Respondent's website, signage and otherwise, consumers are more likely to perceive TRUE separately from the mark as a whole.

33. Respondent uses TRUE alone without CRAFTED in the URL for its main website at <u>https://truepizza.com/</u>, with <u>https://truecraftedpizza.com/</u> being used only to forward visitors to the main website.

34. Respondent is also using TRUE in a number of different TRUE based phrases, just like Petitioner (with some phrases identical to those used by Petitioner).

35. Respondent has also been using TRUE and TRUE PIZZA, rather than TRUE CRAFTED PIZZA, in its Instagram, Twitter and Facebook posts and hashtags, such as @TRUEpizzaCLT and #staytrue. Some representative examples are below:

36. If Respondent's Registration is not cancelled, the continued existence of that Registration on the Principal Register may limit, restrict or interfere with Petitioner's ability to use Petitioner's TRUE Marks in connection with its goods and services.

Standing

37. Petitioner filed its first federal application for TRUE FOOD® on June 17, 2008, which is well before the date when Respondent first applied to register the TRUE CRAFTED PIZZA mark (March 4, 2013).

38. Petitioner has priority over Respondent, with Petitioner's nationwide priority dating back to at least as early as June 17, 2008 for TRUE FOOD®, by virtue of Petitioner's federal registration for TRUE FOOD®.

39. Respondent's use and continued registration of TRUE CRAFTED PIZZA are and/or will be likely to cause confusion with Petitioner's TRUE FOOD® mark and other TRUE Marks.

40. Respondent's use and continued registration of TRUE CRAFTED PIZZA have impaired and/or will impair Petitioner's use of the TRUE FOOD® mark and other TRUE Marks.

41. Respondent's use and continued registration of TRUE CRAFTED PIZZA have caused and/or will cause harm to Petitioner and its business.

Likelihood of Confusion

42. Respondent's use and continued registration of TRUE CRAFTED PIZZA is likely to cause confusion with Petitioner's TRUE FOOD® mark and other TRUE Marks and Petitioner's use of these marks in connection with its restaurant and related services.

43. The predominant word in Respondent's TRUE CRAFTED PIZZA mark as it is actually used by Respondent at the restaurant and on the Internet—namely, TRUE—is identical to the predominant word in Petitioner's TRUE Marks—namely, TRUE.

44. The predominant word in Respondent's mark, TRUE, as it is actually used by Respondent at the restaurant and on the Internet, has the exact same sound and appearance as the predominant word in Petitioner's TRUE Marks.

45. The terms "FOOD" and "CRAFTED PIZZA" are highly related, as crafted pizza is a type of food, and hence TRUE FOOD® and TRUE CRAFTED PIZZA are closely related as a whole.

46. The terms "FOOD" and "CRAFTED PIZZA" are descriptive of the named goods and services covered by Petitioner's and Respondent's respective marks.

47. Respondent's Registration covers the same goods and services that are offered by Petitioner under its TRUE Marks.

48. On information and belief, Respondent offers its goods and services under TRUE CRAFTED PIZZA to the same kinds of consumers to whom Petitioner offers and sells its goods and services under its TRUE Marks.

49. On information and belief, Respondent offers its goods and services under TRUE CRAFTED PIZZA in some of the same or similar channels of trade in which Petitioner offers and sells its goods and services under its TRUE Marks.

50. Respondent markets its goods and services on the Internet and social media, just as Petitioner markets its goods and services on the Internet and social media.

Respondent's use of TRUE CRAFTED PIZZA trades on Petitioner's goodwill in its
 TRUE Marks.

52. On information and belief, some consumers familiar with Petitioner's genuine TRUE FOOD® restaurants, seeing TRUE CRAFTED PIZZA, especially given how Respondent uses a giant TRUE compared to the other words in its signage and elsewhere, and given how Respondent also makes various uses of TRUE without "CRAFTED PIZZA," would mistakenly believe that TRUE CRAFTED PIZZA is associated or affiliated with genuine TRUE FOOD® restaurants.

53. Respondent's TRUE CRAFTED PIZZA mark so resembles Petitioner's TRUE Marks, so as to make it likely, when applied to the registered goods and services, to cause mistake and confusion among, and to deceive, the trade and the public, with consequential injury to Petitioner.

Conclusion

For these reasons, the Board should grant judgment in favor of Petitioner and should cancel Respondent's Registration No. 4,503,098 in accordance with Section 14 of the Trademark Act, 15 U.S.C. §1064.
