MOTION FOR 45 day extension to the requirement to secure U.S. counsel in present proceeding.

Tech And Go Inc.'s respectfully acknowledges receipt of Notice to Petitioner in the current proceeding requiring it to secure U.S. counsel to represent it in this present proceeding. The petitioner was provided 30 days from the date of the letter in which to secure U.S. counsel providing it until December 16 2019 to appoint counsel at which point petitioner requested 30 days time to appoint counsel.

As earlier described Petitioner has been diligent upon receipt of the letter, in working towards securing and appointing counsel, as requested, in the present proceeding. Petitioner however is still in the process of interviewing and selecting counsel, and would require a bit more time to

finalize doing so. Petitioner should likely have requested additional time during the earlier request but in the absence of doing so, petitioner respectfully prays the board to grant the present 45 day request. As of now, petitioner has a potential candidate shortlisted that has begun review, but has not yet been in a position to appoint, as the present firm may need to refer to an outside firm. As a result, petitioner would realistically require a bit more time to appoint counsel.

Tech And Go Inc. therefore respectfully requests that such date be extended 45 days to realistically have enough time for a decision as to the present firm, or for a referral to be made to a different firm, and that any dates be reset accordingly.

As such, the present request of a 45 day extension is being made in good faith and is to provide an opportunity for the petitioner to secure an Attorney to represent it as requested by the board.

The request for a 45 day extension does not prejudice or create any disadvantage to E-filliate, Inc., as having a lawyer represent Tech And Go Inc. in the matter would benefit both sides in working to try and find an acceptable amicable resolution to the matter at hand.

Tech And Go Inc. thus respectfully requests that the present motion be granted.

For the above reasons, Applicant respectfully prays Board grant the current petition for an extension or of 45 days.
