Petitioner hereby moves for a six-month continuation of the suspension with Registrant’s consent. This action was originally suspended due to Civil Action No. 1:19–cv–07465 *The Trustees of Columbia University in the City of New York v. Encyclopaedia Iranica Foundation Inc.* (“the Civil Action”).
