**NOTICE OF VOLUNTARY SURRENDER AND RENEWED JOINT STIPULATION
TO WITHDRAW PETITION FOR CANCELLATION AND COUNTERCLAIM**

Pursuant to the Board’s Order dated May 14, 2021, Petitioner Jam City, Inc. (“Petitioner”) and Respondent Hangzhou Mengku Technology, Co., Ltd., (“Respondent”) hereby respectfully notify the Board that, on May 21, 2021, Respondent voluntarily surrendered U.S. Trademark Registration Nos. 5781760 and 5781759. Copies of Respondent’s Surrender of Registration for Cancellation submissions are attached as **Exhibits A** and **B** hereto.

Further to the Parties’ Joint Stipulation to Withdraw Petition for Cancellation and Counterclaim dated March 31, 2021:

- Petitioner hereby withdraws the pending cancellation proceedings against Registration Nos. 5780987 and 5780982 (for CANDY GENIES), 5804215 and 5804216 (for

- HMT hereby withdraws its pending Counterclaim for Cancellation (“Counterclaim”) of Jam City’s Registration No. 5,383,942 for the “Rainbow Cake” Design Mark; and
- The parties hereby jointly stipulate that Cancellation Proceeding Nos. 92073343 (parent), 92073380, and 92073408, and HMT’s related Counterclaim, be dismissed with prejudice.
