PETITION FOR CANCELLATION

Petitioner, ConSeal International Incorporated ("Petitioner" or "ConSeal"), a Florida corporation, having a principal place of business at 90 Kerry Place, Suite 2, Norwood, MA 02062, believes that it is being damaged by the registration of the mark PHYTOFUSION, shown in U.S. Trademark Registration No. 4,169,328, which has a Registration Date of July 3, 2012, by Medtrition, Inc. ("Registrant"), and hereby petitions to cancel registration of the mark.

As grounds for cancellation, Petitioner asserts as follows:

On August 24, 2011, Registrant (formerly known as National Nutrition, Inc.) filed
 U.S. Trademark Application Serial No. 85/406,114 for the PHYTOFUSION Mark

("PHYTOFUSION Mark" or "Registrant's Mark"), which became registered by the United States Patent and Trademark Office ("USPTO") on July 3, 2012 and was assigned Registration No. 4,169,328 ("the '328 Registration"). This Petition for Cancellation is timely filed.

- 2. Registrant's Mark is registered in connection with "Dietary supplements; Powered nutritional supplement drink mix" in International Class 05. Registrant alleges a date of first use of September 1, 2010.
- 3. However, it is apparent from Registrant's website and other sources, such as Google searches, that Registrant has ceased selling "Phytofusion" products, or never sold them, and has ceased using and abandoned the PHYTOFUSION Mark. Printouts from Registrant's website, www.medtrition.com, reflecting that it does not use the PHYTOFUSION Mark, including the "Products Page" on Registrant's website, are attached hereto as **Exhibit A**. A printout of Google search results for "Phytofusion," reflecting no results for or related to any products sold by Registrant under the PHYTOFUSION Mark or any other use by Registrant of the PHYTOFUSION Mark, is attached hereto as **Exhibit B**.
- 4. Moreover, upon information and belief, Registrant has had no bona fide use of the PHYTOFUSION Mark cited in the '328 Registration in the ordinary course of trade in the United States within the last three years. A printout from the WaybackMachine Internet Archives, reflecting a webpage on Registrant's website as it appeared in 2017 listing products sold by Registrant as of 2017, is attached hereto as **Exhibit C**. As can be seen from Registrant's product page in 2017, Registrant did not sell "Phytofusion" products or otherwise use the PHYTOFUSION Mark in connection with any products in 2017.
- 5. Moreover, upon information and belief and based on the lack of use of the PHYTOFUSION Mark for years, Registrant has no intent to resume use of the PHYTOFUSION

Mark on the goods covered by the '328 Registration.

- 6. As a result, Registrant has abandoned the PHYTOFUSION Mark and the '328 Registration.
- 7. On September 30, 2019, ConSeal filed U.S. Trademark Application Serial No. 88/635,821 for the mark PHYTOFUSION ("the '821 Application"), in connection with "Dietary supplements; nutritional supplements; nutrient food additive powder for use in supplementing human and pet food products for human and animal consumption for healthful advantages; dietary and nutritional supplements for human and animal consumption; dietary supplements for humans and pets; nutritional supplements for humans and pets; botanically derived food additives for use in food products for human and pet consumption for nutrient supplementation" in International Class 05. See Exhibit D, filing receipt for the '821 Application.
- 8. On November 14, 2019, ConSeal received an Office Action from the USPTO in connection with the '821 Application. In the Office Action, the examining attorney refused registration of ConSeal's '821 Application based on a likelihood of confusion with Registrant's '328 Registration.
- 9. Thus, continued registration of the '328 Registration is likely to cause injury and damage to ConSeal and ConSeal's rights in the '821 Application and its applied-for mark and will prevent ConSeal from obtaining federal registration of its PHYTOFUSION mark.
- 10. The '328 Registration should be cancelled for non-use of the PHYTOFUSION Mark for at least three years and abandonment of the PHYTOFUSION Mark.

WHEREFORE, Petitioner respectfully requests that registration of the PHYTOFUSION Mark, shown in U.S. Trademark Registration No. 4,169,328, be cancelled, and that this petition be sustained.






