WITHDRAWAL OF PETITION TO CANCEL WITH PREJUDICE

On January 24, 2022, the TTAB approved the amendment of the description of services for U.S. Reg. No. 4903785, owned by Artlist SAS, and indicated that the amendment will be forwarded to the Post Registration Branch for entry of the amendment, to read as follows,:

“On-line art galleries relating to the fashion industry for artistic directors, illustrators, photographers, stylists, make-up artists, hair stylists, manicurists, and set designers; Advertising and promoting the goods and services of artists; promoting the goods and services of others.”

On January 27, 2022, the Post Registrant Branch processed and entered the above-referenced amendment, under Section 7, which has now been updated in the USPTO Trademark Status & Document Retrieval (TSDR) records.

¹ On December 20, 2021, Registrant filed with the USPTO Assignment Division documentation reflecting the June 30, 2017 Entity Conversion from Artlist SARL (“Société à responsabilité limitée”) to Artlist SAS (“Société par actions simplifiée”), which is recorded at Reel/Frame 7555/0001.


Petitioner ARTLIST LTD. confirms that entry of the above-referenced amendment shall resolve this proceeding.
