CONSENTED MOTION FOR CONTINUATION OF THE SUSPENSION

Registrant hereby moves for a six-month continuation of the suspension with Petitioner’s consent. This action was originally suspended due to Civil Action No. 1:19–cv–07465 *The Trustees of Columbia University in the City of New York v. Encyclopaedia Iranica Foundation Inc.* (“the Civil Action”).

The Civil Action was recently dismissed without prejudice by the U.S. District Court for the Southern District of New York, subject to the right to reopen under certain circumstances, after the parties reached a settlement. However, because certain conditions of settlement still have to be met, Registrant requests that this proceeding remain suspended for an additional six months.

Petitioner's counsel has consented to this request for continuation of the suspension.
