**JOINT MOTION TO AMEND AND DISMISS**

Pinewood Social, LLC (“Petitioner”) filed a petition to cancel U.S. Registration No. 5,505,362 for “PINEWOOD” and Design (the “’362 Registration”), owned by Pinewood Group Ltd. (“Respondent”). Pursuant to the agreement entered into by the parties, the parties move the Board to take the following steps:

Respondent moves the Board to modify and limit the identification of services in Class 43 in Respondent’s ’362 Registration as follows:

**Restaurant services associated with film and television studios; catering associated with film and television studios and productions; cafes associated with film and television studios; providing temporary accommodation; provision of facilities for conducting conferences and conventions.**

Clean

Restaurant services associated with film and television studios; catering associated with film and television studios and productions; cafes associated with film and television

studios; providing temporary accommodation; provision of facilities for conducting conferences and conventions

Petitioner consents to the proposed amendments. All other Classes in the '362 Registration remain unchanged.

The parties request that the present Cancellation Proceeding be suspended pending the Board's decision upon the foregoing proposed amendment to the Respondent's description of services in Class 43. Contingent upon the Board's acceptance of the amendments to the '362 Registration, and pursuant to the terms of the agreement entered into by the parties, Petitioner hereby withdraws this Cancellation Proceeding with prejudice.
