Petitioner Nutrinnocent Pte. Ltd., a Singapore private limited company having its principal place of business at 531A Upper Cross Street, #04-95 Hong Lim Complex, Singapore 05153 Singapore, (“Petitioner”), believes that it is and will be damaged by Reg. No. 2,845,102 of NIFTY in Class 30 (the “Registration”) owned by D.F. Stauffer Biscuit Co., Inc., a Pennsylvania corporation, having a place of business of Belmont and Sixth Avenue, P.O. Box 1426, York, Pennsylvania 17405-1426 (“Registrant”), and hereby petitions to cancel the Registration on the following grounds:

**PETITIONER’S ALLEGATIONS**

**A. Petitioner’s Application to Register NIFTY**

1. On April 1, 2020, Petitioner filed the Application in the Office seeking registration, based on its Madrid Protocol application, of NIFTY for use with “dietary

supplements; dietary food supplements; dietary and nutritional supplements; health food supplements for persons with special dietary requirements; herbal dietary supplements for persons with special dietary requirements; herbal remedies, namely, herbal supplements for sleeping problems, anxiety, blood pressure, respiratory and cough; liquid herbal supplements; mineral food supplements; mineral dietary supplements for humans; health food supplements made principally of minerals; vitamins; vitamin supplements; vitamin preparations for human consumption; health food supplements made principally of vitamins; vitamin tablets; vitamin C preparations; protein dietary supplements; protein supplements for human consumption; vegetal protein supplements for human consumption; food supplements with added proteins for use by athletes; nutritional supplement energy bars; probiotic bacterial preparations for medical purposes” in Class 5, and “vegetable-based snack foods; nut-based snack bars; seed-based snack bars; fruit-based snack bars; dried fruit-based snack bars; processed chickpeas; dried shiitake mushrooms; dried fruit products, namely, dried fruit mixes; tropical fruits, dried; dried fruits in powder form; root vegetables, dried; dried berries being whole, or in crushed or powder form; dried vegetables in powder form; dried edible mushrooms; seeds prepared for human consumption, not being seasonings or flavorings; edible oils and fats; coconut oil for food; processed edible seaweed; edible nuts being process nuts” in Class 29, which application has been assigned Ser. No. 79/286,561 (“Application”). True and correct copies of the TESS and TSDR pages for the Application are attached hereto as **Exhibit A**.

2. The Application has been refused by the Office on the grounds of a likelihood of confusion with the Registration.

**B. Registrant’s Application to Register NIFTY and Resulting Registration**

3. On March 10, 1999, Registrant applied to register the mark NIFTY for “cookies and crackers” in Class 30, on an intent-to-use basis. This application was assigned Serial No. 75/657,963.

4. On February 3, 2004, Registrant filed a Statement of Use, claiming a date of first use anywhere and in commerce of January 24, 1956. To substantiate its claimed use of the mark, Registrant submitted as a specimen a photograph of a bag of animal crackers. Based on the specimen and accompanying statement of use, the application matured to registration on May 25, 2004.

5. On June 12, 2009, Registrant filed its Combined Declaration of Use and Incontestability Under Sections 8 and 15. On July 15, 2013, Registrant filed its Combined Declaration of Use and Renewal under Sections 8 & 9. In support of both, Registrant submitted a photograph of the same packaging referred to in Paragraph 4. Registrant's Attorney of Record signed the Declarations under 18 U.S.C. Section 1001.

6. True and correct copies of the TESS and TSDR pages for the Registration are attached hereto as **Exhibit B**.

**FIRST BASIS FOR CANCELLATION  
(Abandonment)**

6. Petitioner incorporates by reference the allegations contained in Paragraphs 1 to 5 herein.

7. Petitioner has undertaken a reasonable investigation and has not found any current use by Registrant of the NIFTY mark for the goods identified in the Registration in the U.S. or anywhere else, whether that use be in the form of the packaging referred to in Paragraph 4 or otherwise.

8. On information and belief, Registrant is not currently using the NIFTY mark for the goods identified in the Registration in the United States or anywhere else.

9. On information and belief, Registrant has not used the NIFTY mark for the goods listed in the Registration in the United States for more than three consecutive years, thereby demonstrating a *prima facie* case of abandonment under 15 U.S.C. § 1127.

10. On information and belief, Registrant does not intend to resume use of the NIFTY mark for the goods listed in the Registration within the reasonably foreseeable future.

11. Registrant has abandoned the NIFTY mark.

**DAMAGE CAUSED TO PETITIONER**

12. Petitioner is damaged by the maintenance of the Registration because it gives Registrant a *prima facie* exclusive right to use NIFTY for the goods in the Registration throughout the United States and is barring registration of the Application.

12. Petitioner therefore petitions to cancel the Registration on the grounds that Registrant has abandoned use of NIFTY for the goods identified in the Registration.

WHEREFORE, Petitioner prays that the Registration be canceled. The required fee of \$600 for this Petition to Cancel has been charged to Deposit Account No. 50-4561.
