**CONSOLIDATED PARTIAL PETITION FOR CANCELLATION
TO RECTIFY THE REGISTER**

Dear Sir or Madam:

Pursuant to Sections 14 and 18 of the Trademark Act, 15 U.S.C. §§ 1064, 1068 and TBMP § 309.03(d), Public Storage (“Petitioner”) believes that it has been and will continue to be damaged by the continued registration of the marks shown in U.S. Registration Nos. 2,434,540

and 2,557,602 (the “Registrations”) for the marks GLENBOROUGH and  in Class 36, owned by GLENBOROUGH, LLC (“Respondent”), which contains Petitioner’s registered trademark PUBLIC STORAGE® in the recitation of services of Respondent’s Registrations. Petitioner hereby partially petitions to cancel the same and requests the Board rectify the Registrations to delete Petitioner’s registered trademark PUBLIC STORAGE® from


the recitation of services and substitute the generic wording “self-storage”, which would be consistent with the USPTO’s *per se* policy prohibiting the inclusion of registered trademarks in the recitation of services.

As grounds for this Petition, it is alleged that:




1) Petitioner is a leader in the storage industry with over 2,500 facilities in the United States and annual revenue exceeding \$2.7 Billion. Petitioner provides self-storage facilities and services as well as associated goods and services under its PUBLIC STORAGE® mark.

2) Since at least as early as 1972, long before the filing date and alleged first use date of the Subject Registrations, Petitioner has been, and still is, engaged in providing Petitioner's services using its PUBLIC STORAGE® mark.

3) Petitioner is the owner of numerous U.S. registrations for and including the PUBLIC STORAGE® mark.

4) Public Storage is the owner of and relies on U.S. Trademark Registration No. 1132868 (the "'868 Registration") for the PUBLIC STORAGE® mark for "renting of private storage spaces with limited access" in Class 39, which registration issued April 8, 1980 and is based on an application filed with the USPTO on October 23, 1978. The '868 Registration is incontestable. The filing date of Public Storage's '868 Registration is prior to the filing date and alleged first use date of the Subject Registrations. True and correct copies of the specifics of the '868 Registration obtained from the USPTO's TESS and Assignment databases are attached hereto as Exhibit 1 and made of record.

5) In addition, Petitioner owns the following U.S. trademark registrations for and including the PUBLIC STORAGE® mark:

All of the above-referenced registrations are incontestable. All of the filing dates of the above-referenced registrations are prior to the filing date and alleged first use date of the subject Registrations. True and correct copies of the specifics of the above-referenced registrations obtained from the USPTO's TESS and Assignment databases are attached hereto as Exhibit 2 and made of record.

6) The inclusion of Petitioner's registered trademark PUBLIC STORAGE® in the identification of services in Respondent's Registrations is inconsistent with Petitioner's rights in the PUBLIC STORAGE® mark and is contrary to and violates the *per se* policy of the USPTO prohibiting the inclusion of a registered trademark in the recitation of services. *See, e.g.*, TMEP § 1402.09 which provides the following:

If a mark that is registered to an entity other than the applicant is used in the identification of goods or services, the examining attorney **must require that it be deleted and that generic wording be substituted**. It is **inappropriate to use a registered mark**, or its plural or punctuated/non-punctuated forms, to identify a kind of product or a service, because such a mark indicates origin in only one party and cannot be used to define goods or services that originate in a party other than the registrant. *Camloc Fastener Corp. v. Grant*, 119 USPQ 264, 265 n.1 (TTAB 1958). **In place of the mark, a generic term must be used.**

7) Consequently, Respondent's Registrations should not have issued incorporating Petitioner's registered trademark PUBLIC STORAGE® in the recitation of services contrary to and in violation of the USPTO's *per se* policy. In fact, the Examining Attorney should have

required that the registered trademark be deleted and the generic wording (*i.e.*, “self-storage”) be substituted in the recitation of services.

8) Pursuant to TBMP 309.03(d), the Board has authority to “rectify” the register with respect to the recitation of services and other aspects of the registration. *See, e.g.*, TBMP 309.03(d), which provides the following:

A claim to restrict or rectify with respect to the register the registration. A petition to restrict or clarify the description of a mark in a registration would fall under the provision giving the Board authority to "restrict or rectify" the register. As in the case of a petition to restrict goods or services, a proper pleading to restrict the description of a mark could include allegations that, for example, the description of the mark in the registration is ambiguous or overly broad and not specific to the mark actually used by the defendant, and that the limitation would avoid a finding of a likelihood of confusion.

That same provision, along with the authority to "register the mark...for the person...entitled thereto," allows the Board to correct, respectively, a registration or application to identify the true owner, if such correction is warranted.

Moreover, such partial petitions to cancel can be filed at any time, even for registrations over 5 years old, because the nature of this claim is an equitable remedy.

A petition to partially cancel a registration by restricting the goods or services in a particular manner ... **is in the nature of an equitable remedy** and does not constitute an attack on the validity of a registration.

See id.

9) Accordingly, Petitioner will be damaged by the continued registration of the



GLENBOROUGH and marks as the Registrations will conflict with Petitioner’s registration for the PUBLIC STORAGE® mark.

10) WHEREFORE, Petitioner requests that U.S. Trademark Registration Nos. 2,434,540 and 2,557,602 be cancelled in part to rectify the register, and that the wording “public storage” in the identification of services be replaced with the generic wording “self-storage” such that the identification of services reads “Investment services, namely, acquiring real estate

operating or management companies for others; [condominium resort management;] real estate investment; real estate management; leasing and rental of industrial, office, retail, multi-family, ~~public storage self-storage~~, and shopping properties; investment and management in the nature of public and private securities; financing services, namely, providing debt and equity financing relating to the acquisition or development of real estate” services in Class 36 for Registration No. 2,434,540, and “Investment services, namely, acquiring real estate operating or management companies for others; [condominium resort management;] real estate investment; real estate management; leasing and rental of industrial, office, retail, [multi-family,] ~~public storage self-storage~~, and shopping properties; investment and management in the nature of public and private securities; financing services, namely, providing debt and equity financing relating to the acquisition or development of real estate” services in Class 36 for Registration No. 2,557,602, and that this Consolidated Partial Petition for Cancellation be sustained in favor of Petitioner.

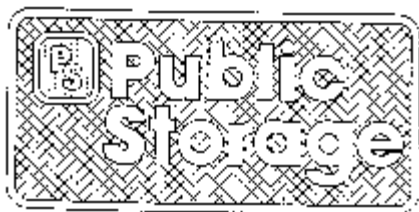

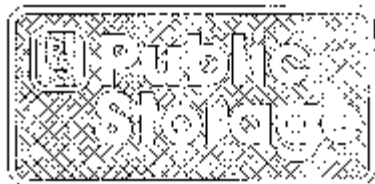
