The Board notes that an entity conversion from INSPR, LLC to INSPR, Inc. was recorded with the Assignment Recordation Branch of the USPTO on June 15, 2021 at Reel/Frame 7327/0596. The Board also notes that an assignment of the subject registration from INSPR Inc. to INSPR Partners LLC was recorded with the Assignment Recordation Branch of the USPTO on July 9, 2021 at Reel/Frame 7350/0908 (this assignment allegedly took effect on October 14, 2020).

When there has been an assignment of a mark that is the subject of, or relied upon in, an inter partes proceeding before the Board, the assignee may be joined or substituted, as may be appropriate. *See* TBMP § 512.01. The Board's record is hereby

updated to reflect the entity conversion from INSPR, LLC to INSPR, Inc. INSPR Partners LLC is hereby joined as a party-defendant.¹

The parties are advised that Board will not carry on dual correspondence. *See* Trademark Rule 2.18. In accordance with Board practice and Trademark Rule 2.18, the joint **Respondents are allowed until 20 days from the mailing date of this order to file and serve a notice appointing one lead counsel**, failing which the Board's future correspondence will only be sent to Respondents' current correspondence address of record.² The lead counsel or authorized representative in turn will be responsible for making and distributing any postal copies of Board correspondence to each defendant or its attorney or other authorized representative. In these cases, the lead counsel is not substituted for the separate counsel or representative of each defendant, but rather is responsible for coordinating the conduct of the defendants' case. However, by designating more than one email address for receipt of notice of Board actions, all representatives may receive electronic correspondence from the Board.

Proceedings are **suspended** until Respondents comply with the above requirement.
