PETITION FOR CANCELLATION

NOBULL, LLC (“Petitioner”), by and through its undersigned counsel, hereby petitions for cancellation of the mark depicted in Registration No. 6,365,548 (the “’548 Registration”), purportedly owned by DMoose Enterprises Inc. (“Respondent”). Petitioner states the following grounds in support:

1. Petitioner is a limited liability company organized and existing under the laws of Delaware and has a place of business at 105 South Street, Boston, Massachusetts 02111.
2. Respondent is a corporation organized and existing under the laws of Wyoming and has a place of business at 412 North Main Street, Suite 100, Buffalo, Wyoming 82834.
3. Petitioner has made continuous, extensive, and substantially exclusive use in interstate commerce of the mark NOBULL since at least as early as July 2013 in connection with at least athletic apparel and accessories, and owns common law rights in the mark NOBULL.
4. In addition to its common law rights, Petitioner owns U.S. Trademark Registration No. 5,258,547 for NOBULL for “gym bags; hard-sided and soft-sided carry-on bags

and gym bags; hiking bags; sports bags” in International Class 18; and “athletic apparel, namely, shirts, pants, jackets, footwear, hats and caps, athletic uniforms; athletic footwear; athletic pants; athletic shirts; athletic shorts; athletic tops and bottoms for use during exercise; footwear; shirts; shorts; sport shirts; sweat shirts; t-shirts,” in International Class 25 (the “‘547 Registration”). The ‘547 Registration issued on August 8, 2017. Attached as **Exhibit A** is a printout of the USPTO electronic database record for the ‘547 Registration.

5. Petitioner also owns U.S. Trademark Registration No. 5,337,792 for the mark shown below for “gym bags; hard-sided and soft-sided carry-on bags and gym bags; hiking bags; sports bags” in International Class 18; and “athletic apparel, namely, shirts, pants, jackets, footwear, hats and caps, athletic uniforms; athletic footwear; athletic pants; athletic shirts; athletic shorts; athletic tops and bottoms for use during exercise; footwear; shirts; shorts; sport shirts; sweat shirts; t-shirts” in International Class 25:

NOBULL

(the “‘792 Registration”). The ‘792 Registration issued on November 21, 2017. Attached as **Exhibit B** is a printout of the USPTO electronic database record for the ‘792 Registration.

6. Petitioner also owns U.S. Trademark Application Serial No. 88/646,474 for NOBULL for “sunglasses, eyewear” in International Class 9; “watches” in International Class 14; “luggage” in International Class 19; “physical fitness equipment, namely, exercise bands, weight belts, training bars, exercise weights, and bicycles” in International Class 28; and “organizing and conducting athletic competitions and games in the field of general fitness, exercise, track and field, and weightlifting; personal training fitness services” in International

Class 41 (the “‘474 Application”). The ‘474 Application was filed on October 8, 2019. Attached as **Exhibit C** is a printout of the USPTO electronic database record for the ‘474 Application.

7. Through extensive promotion and use, Petitioner has created valuable goodwill in its NOBULL mark, which mark is famous and represents high quality products to consumers throughout the United States.

8. Notwithstanding Petitioner’s prior rights described above, Respondent filed an application for NO MORE BULL. for “sports and strength training equipment, namely, wrist wraps, weightlifting straps, weightlifting belt” in International Class 28. The application was filed on February 28, 2020 under U.S. Trademark Application Serial No. 88/814,986, which application issued on the Principal Register as the ‘548 Registration on May 25, 2021.

9. In the ‘548 Registration, Respondent claims a first use anywhere date of August 1, 2019 and a first use in commerce date of January 10, 2020.

10. Respondent’s filing date and alleged dates of first use in the ‘548 Registration are junior to Petitioner’s first use of the NOBULL mark.

COUNT I
Likelihood of Confusion Under 15 U.S.C. § 1052(d)

11. Petitioner incorporates paragraphs 1 through 10 by reference.

12. Respondent’s NO MORE BULL. mark is confusingly similar to Petitioner’s NOBULL mark in appearance, sound, connotation, and commercial impression.

13. The goods identified in the ‘548 Registration are closely related to the goods and services offered by Petitioner under its NOBULL mark, and are likely to be encountered by the same class of consumers.

14. In light of the similarities in appearance, sound, connotation, and commercial impression between the marks and the relatedness of the goods, consumers are likely to believe
