OPPOSITION TO PETITIONER DISH NETWORK L.L.C.’S MOTION FOR SANCTIONS

Respondent, Onstreaming LLC, provides its opposition to Petitioner Dish Network LLC Motion for Sanctions. Respondent’s opposition is based on the substantial settlement efforts made to date and as such, Respondent respectfully requests the Board to deny Petitioner’s motion or, to the extent it is receptive to grant an extension of time to respond to the discovery request or to suspend the proceeding based on settlement discussions.

Specifically, the parties have drafted a co-existence agreement in contemplation of settlement and have previously suspended the proceedings based on settlement negotiations. The remaining issues within the co-existence are minimal and could likely result in an agreement between the parties during a short period of time.

Respondent has timely served its Initial Disclosures and provided discovery responses, in which Petitioner challenges the sufficiency of the responses.
