#### **PETITON FOR CANCELLATION**

WOMEN'S BEST GmbH, an Austrian limited liability company with an address of Eduard Bodem Gasse 3, Innsbruck, Austria A-6020 ("Petitioner"), believes that it will be damaged by SAND ONE LLC's ("Respondent") continued registration of U.S. Trademark Registration No. 5,276,240 for the mark SAND ONER in connection with "Body suits; Hats; Leggings; Pants; Shirts; Socks; Sweaters; Tank-tops; Underwear; Bottoms; Hoodies; Hoods; Jackets; Sports caps and hats; Sports caps and hats; Top" in Class 25 (the "Respondent Registration") and hereby petitions for cancellation of same on grounds of fraud and non-use pursuant to Section 14 of the Lanham Trademark Act of 1946 (the "Lanham Act"), 15 U.S.C. § 1064 and on grounds of abandonment pursuant to Section 14(3) of the Lanham Act, 15 U.S.C. § 1064(3). As grounds for cancellation, Petitioner alleges as follows:

1. On February 28, 2020, Petitioner filed U.S. Application Serial No. 88/815,408 based on Section 1(b) for registration of the mark ONER (with design) for "Rucksacks; Bags for sports" in Class 18 and "Tops as clothing; Bottoms as clothing;

Clothing for gymnastics, namely, shorts, shirts, leggings, and pants; Track suit bottoms; Jerseys; Gym suits; Tank tops; Shorts; Shirts; T-shirts; Trousers; Pants; Waistcoats; Coats; Headgear, namely, sports caps, hats, toboggan hats, beanies, skull caps, bandanas, headbands, and sweatbands; Headwear; Footwear" in Class 25 (the "ONER Application").

- 2. On July 1, 2020, Petitioner filed U.S. Application Serial No. 90/031,906 based on Section 1(b) for registration of the mark ONER ACTIVE (with design) for "Rucksacks; Bags for sports" in Class 18 and "Tops as clothing; Bottoms as clothing; Clothing for gymnastics, namely, shorts, shirts, leggings, and pants; Track suit bottoms; Jerseys; Gym suits; Tank tops; Shorts; Shirts; T-shirts; Trousers; Pants; Waistcoats; Coats; Headgear, namely, sports caps, hats, toboggan hats, beanies, skull caps, bandanas, headbands, and sweatbands; Headwear; Footwear" in Class 25 (the "ONER ACTIVE Application" and together with the "ONER Application" referred to herein as "Petitioner's Applications").
- 3. Petitioner's Applications are pending. Attached hereto as <u>Exhibit A</u> are true and correct printouts from the United States Patent and Trademark Office ("USPTO") electronic database reflecting that Petitioner's Applications are pending.
- 4. In respective Office Actions dated May 19, 2020, and October 9, 2020, the USPTO cited the Respondent Registration against Petitioner's Applications (the "Office Actions"), asserting its position that registration of the ONER and ONER ACTIVE marks are likely to cause confusion with the SAND ONER mark. Both Office Actions have since been made final, thereby interfering with Petitioner's Applications and causing harm to Petitioner. Petitioner therefore has a real interest in seeking cancellation of the Respondent Registration and standing to bring this action.

- 5. Respondent, a California limited liability company with an address of 206W. 4th St., Suite 209, Santa Ana, CA 92701, is the current listed owner of the Respondent Registration.
- 6. On February 3, 2017, Respondent filed Application Serial No. 87/324,492 ("Respondent's Application") to register the SAND ONER mark for, in pertinent part, "Body suits; Hats; Leggings; Pants; Shirts; Socks; Sweaters; Tank-tops; Underwear; Bottoms; Hoodies; Hoods; Jackets; Sports caps and hats; Sports caps and hats; Tops" in Class 25 based on purported use of the mark in U.S. commerce under Section 1(a) of the Lanham Act.
- 7. The specimen submitted with Respondent's Application shows one digitally created image of an article of clothing. The clothing pictured does not display the SAND ONER mark, does not include a tag displaying the mark, or otherwise include an acceptable specimen showing use of the mark in commerce. A true and correct copy of which is attached hereto as <a href="Exhibit B">Exhibit B</a>. In Respondent's Application, a true and correct copy of which is attached hereto as <a href="Exhibit C">Exhibit C</a>, Respondent's Attorney of Record, Elizabeth Yang ("Yang"), on Respondent's behalf, represented to the USPTO that Respondent was actively using the SAND ONER mark in U.S. commerce in connection with "Body suits; Hats; Leggings; Pants; Shirts; Socks; Sweaters; Tank-tops; Underwear; Bottoms; Hoodies; Hoods; Jackets; Sports caps and hats; Sports caps and hats; Tops" in Class 25 (the "Representation").

#### COUNT I – FRAUD ON THE U.S. PATENT AND TRADEMARK OFFICE

8. Petitioner repeats and realleges paragraphs 1 through 7 hereof, as if fully set forth herein.

- 9. Petitioner seeks to cancel the Registration on the ground that it was obtained as a result of at least one knowingly false statement about use of the SAND ONER mark, which was made with the intent to deceive the USPTO and constitute fraud on the USPTO.
- 10. On information and belief, the Representation was false at the time Yang made it on Respondent's behalf.
- 11. The only reasonable inference from the foregoing is that the Representation was made on Respondent's behalf to mislead the USPTO and to cause the USPTO to issue the Respondent Registration.
- 12. The false Representation was material because, but for the false Representation, the USPTO would not have granted the Respondent Registration. However, in reliance on the false Representation, the USPTO issued the Respondent Registration on August 29, 2017.
- 13. Petitioner has been and will continue to be harmed by the issuance of the Respondent Registration because it is preventing Petitioner from obtaining a registration for its ONER and ONER ACTIVE marks and Respondent could rely on the Respondent Registration to assert its alleged rights against Petitioner.
- 14. Based on the foregoing, Respondent obtained the Respondent Registration fraudulently, which is grounds for cancellation of the Respondent Registration in its entirety.

## COUNT II – NO USE OF MARK IN COMMERCE BEFORE STATEMENT OF USE

15. Petitioner repeats and realleges paragraphs 1 through 14 hereof, as if fully set forth herein.

16. As a further basis for cancellation, the Respondent Registration is void ab

initio because Respondent was not using the SAND ONER mark in connection with any

of the goods identified in Respondent's Application when it was filed on February 3, 2017.

**COUNT III – ABANDONMENT** 

17. Petitioner repeats and realleges paragraphs 1 through 16 hereof, as if fully

set forth herein.

18. On information and belief, to the extent Respondent ever used the SAND

ONER mark in commerce, Respondent has discontinued use of the SAND ONER mark in

connection with all the goods identified in the Respondent Registration.

19. Accordingly, Respondent has abandoned the SAND ONER mark and

Respondent's Registration is subject to cancellation pursuant to 15 U.S.C. § 1064(3).

WHEREFORE, Petitioner respectfully requests that its cancellation be sustained,

and that Respondent's Registration No. 5,276,240 be cancelled.






