**PETITIONER KP APPAREL GROUP, INC.’S  
THIRD MOTION TO EXTEND TIME TO RESPOND WITH CONSENT**

Petitioner KP Apparel Group, Inc. (“KP Apparel”) hereby moves to extend its time an additional thirty (30) days for Petitioner to respond to Registrant’s Motion to Dismiss (13 TTABVUE). The remaining deadlines are currently suspended pending disposition of the Motion to Dismiss (14 TTABVUE).

KP Apparel’s deadline to files its response is currently set for April 11, 2022. KP Apparel requests that such date be extended for 30 days until May 11, 2022. Counsel for Registrant has consented to this extension. This is the third request for extension of time by KP Apparel. KP Apparel’s instant motion to extend its time to respond is not being filed for the purposes of delay or to obtain an unfair advantage. This cancellation action was filed by Petitioner because Registration No. 3,975,111 was asserted in a litigation action against Petitioner in the Southern District of Florida (Case No. 1:20-cv-25193), which is in the final process of settlement. The settlement papers are expected to be signed this week. Once those signatures are finalized, Petitioner will dismiss the present cancellation action.

KP Apparel respectfully requests that the Board extend KP Apparel’s time to respond by 30 days until May 11, 2022, to allow the settlement to be finalized.
